On May 2nd 2015, NYPD Police Officer Brian Moore, son to Irene & Raymond Moore, brother to Christine Moore, and hero to all New Yorkers; was shot and killed as he performed his duties as a plainclothes police officer in the 105th Precinct's anticrime patrol unit. Beloved by his family, friends, and fellow NYPD officers; Officer Brian Moore was a "Cop's Cop" and a shining example of the dedicated service that NYPD officers provide on a daily basis. Office Moore's service to our community, borough and City was considered invaluable and after his passing, Officer Moore was posthumously promoted to Detective 1st Grade by Police Commissioner Bill Bratton. In December, Assemblyman Weprin was honored to join NYPD Commissioner Bill Bratton, Councilman I. Daneek Miller, Assistant Chief David Barrere, PBA President Patrick Lynch, CB 13 Chairman Bryan Block and other elected officials to co-name the corner of 222nd Street and 92nd Avenue outside the 105th Precinct in Queens Village as "Detective 1st Grade Brian Moore Way."


