Greetings -

Last week, I was in Albany to Chair a public hearing of the Assembly's Committee on Libraries and Education Technology on the subject of "The Future of Libraries and Their Integration of Electronic Materials." The Committee heard testimony from the New York State Librarian, the New York Association of Libraries, and representatives of library systems from across the state who delved into both the challenges and opportunities facing libraries especially with regards to digital materials. I will continue to use my platform as Chair of the Committee to advocate for robust support for libraries in the State's budget but will also be working to develop legislation that will enable libraries to make their dollars go further.



Leading Literacy Summit

While in Albany I also attended the "Leading Literacy Summit" sponsored by the Science of Reading Center at SUNY New Paltz and EdTrust-NY. I moderated a panel that included Deon Butler, a former NFL player – now a leading dyslexia advocate, and Dr. Kymyona Burk, the policy architect behind Mississippi's remarkable success in implementing evidence-based practices and improving reading proficiency among its students. The summit was yet

another affirmation that we need a statewide mandate regarding evidence-based literacy curriculum like that included in my Right to Read legislation (A.78). I recently sent a formal request to the Board of Regents - the state body with the power to act - urging them to set clear, statewide standards for every public school.



As part of my ongoing advocacy around literacy education over the last two weeks I released a series of three videos explaining the problem – why according to national test scores less than 72% of New York City fourth graders are reading at grade level – and how we can fix it.
