## What's New in the District?

#### **ENDING CASH BAIL IN NEW YORK STATE**

The Assembly Majority worked diligently to enact a 2019-20 state budget that addresses the systemic issue of cash bail. One provision eliminates cash bail for misdemeanors – excluding sex offense misdemeanors – and non-violent felonies, allowing individuals to be released on their own recognizance or under non-monetary conditions, including pretrial supervision. The budget also requires police officers to give desk appearance tickets in lieu of making a custodial arrest for many lower-level offenses with certain exemptions. The court will also retain the option to set cash bail for a person charged with a misdemeanor sex offense and for most violent felony charges.

### \$750,000 TO RESTORE TENANT PILOT PROGRAM FOR NYCHA!

The Resident Watch Program is a program dedicated to tenants who are deeply concerned about everyone's safety. The Resident Watch program will be funded \$750,000 to help provide small financial incentives for residents who care about the safety and welfare of their neighbors and their community.

### **COMBATTING GUN VIOLENCE IN OUR COMMUNITIES**

New York City's Department of Health has deemed gun violence a public issue showing histories of violent behavior in communities. Due to the ongoing fight against gun violence in the 55th Assembly District there has been a dire need to curb gun violence while simultaneously strengthening our gun laws. Cure Violence programs within the 55th Assembly District will receive \$600,000 in funding to combat gun violence.

### **CHAIR**

Taskforce on Women's Issues: responsible for giving women a greater voice in state government, works closely with women's groups, community organizations, state agencies and other legislators to propose new legislation, promote passage of pending legislation and advocate for funding of programs serving women.

**Renewable Energy:** jurisdiction over legislation that addresses increasing concerns over an overdependence on climate threatening fossil fuels.



## COMMITTEES

Housing: responsible for legislation concerning housing development and preservation. Its purview includes rent regulation, as well as legislation that amends volumes of the New York consolidated laws such as; multiple dwelling law; multiple residence law; private housing finance law (which governs state programs like Mitchell-Lama); and public housing law.

Energy: jurisdiction over legislation relating to energy availability and sources, policy and planning, conservation, and electric, gas and steam rate-making in New York State.

Election law: jurisdiction over all legislation that affects elections such as ballot access, voter registration and enrollment, voter education and outreach, campaign financing and related administrative procedures.

**Correction:** jurisdiction over legislation affecting all aspects of the operations of both state and local correctional facilities, with 54 state correctional facilities and 62 local correctional systems, including all local jails and police lockups operated by municipalities across New York State. New York has approximately 53,000 inmates in state facilities and 27,370 inmates in local facilities.

Insurance: jurisdiction over legislation that would preserve essential health benefits and promote quality health care in New York State.
