LEGISLATIVE UPDATE

Legislation Introduced by Assemblymember Jaime Williams

A.10632: Relates to prohibiting transportation network companies from including mandatory arbitration clauses in user agreements for certain offenses including assault and sex offenses; all user agreements issued with such clause shall be considered null and void and new agreements without such clause shall be issued within 14 days of the effective date of this legislation.

A.10512: An act to amend the vehicle and traffic law, in relation to requiring weather radios in motor vehicles sold within the state with a model year of 2021 or later.

A.7627: To ensure that in addition to all other escalating costs and expenses facing college students and all students of higher education, a Reduced-Fare MetroCard can help alleviate some of the financial burden with traveling to and from their institution of higher learning.
