ENSURING AN EQUITABLE RECOVERY

More than a year has passed since COVID-19 upended our lives. After enduring a deeply challenging time, our community can start to breathe a sigh of relief as subways, restaurants, and cultural institutions begin to re-open. Now, my colleagues and I are focused on ensuring that our City and State come back safer, fairer, and more livable than before. I'm proud of our progress, both within our local community and at the State Legislature.

Locally, my office has led vaccine information sessions, organized vaccine pop-up clinics, and supported tenants and small businesses with rent relief. Legislatively, we committed to a fair recovery for all in our historic budget, which protects against housing instability, unemployment, and educational inequities. We allocated the highest level of state aid ever given to school districts for the 2021-2022 school year. We created an "Excluded Workers" fund to help our neighbors without access to other forms of support; a COVID-19 Emergency Rental Assistance Program; and a historic Arts Recovery and Revitalization Program. We also finally passed a millionaire's tax so the best off among us can help those struggling most.

In addition, the Legislature enacted landmark legislation that protects New Yorkers who faced marginalization even before COVID-19. Our vote to end the use of long-term solitary confinement in jails, for example, will address human rights violations and improve safety for those in our criminal justice system. I am pleased we also took a tremendous leap toward equity by legalizing recreational marijuana. This law will expunge the felony drug records of tens of thousands of New Yorkers — many from communities of color disproportionately targeted by our War on Drugs — while investing 40% of future marijuana tax revenues in neighborhoods most harmed by drug arrests. This is just one of many measures that will solidify New York's standing as a progressive leader.

RECENT LEGISLATIVE VICTORIES

Restoring the Right To Vote

I am thrilled to share that my bill restoring voting rights to New Yorkers on parole has become law. I wrote this bill over ten years ago, and I'm grateful to see our state buck national trends with this historic expansion of voting rights. Now, individuals on parole will be allowed to vote upon their re-entry to civil society and will be given notice and a voter registration form. I am deeply proud of this bill, which dismantles the vestiges of Jim Crow-era felony disenfranchisement in New York and affirms that every citizen has equal worth and deserves the right to vote.

Protecting Our Environment

My bill banning the use of hydrofracking by-products for de-icing became law — a huge environmental victory. Harmful fracking wastewater had been used on our state highways to de-ice in the winter and suppress dust in the warmer months — but this also exposed our water supply and vulnerable communities to dangerous contaminants that are all too often present in fracking wastewater. My bill keeps our communities, and our state, safer.

THE WORK AHEAD

Ending Grand Jury Secrecy

Seven years have passed since Eric Garner was murdered, and we still don't know why a grand jury declined to indict Officer Daniel Pantaleo. For the public to have confidence that justice has been served, they need to know exactly how the indictment process is being carried out. My bill to end grand jury secrecy would allow the release of records showing the charges presented to grand juries, and what the jury was instructed.


Banning Dangerous No-Knock Raids

No-knock raids like the one that killed Breonna Taylor last year are dangerous, costly, and all too often result in an unintended loss of life. That's why I am proud to sponsor pioneering legislation that would make our state a national leader in search warrant reform. This proposed bill will restrict the issuance and execution of all no-knock warrants and raids while also introducing new measures of oversight.

TEN YEARS OF LGBTQ PROGRESS

Ten years ago, New York State passed the Marriage Equality Act, which allowed same sex couples like my now-husband John and me to get married. Like all important fights, the political battle to achieve equality was long and arduous. As the first openly gay man elected to the New York State Assembly in 2002, it took me years of organizing advocates, speaking publicly, and speaking to my colleagues one-on-one to convince them to see me and the LGBTQ community as equal. Finally, in 2011, the bill I wrote passed the Assembly, the Senate, and was signed into law.

In New York, marriage equality opened the door for a steady stream of LGBTQ progress. In 2012, my anti-bullying Dignity for All Students Act became the first law in New York State history that explicitly included transgender people. We have passed GENDA, banned conversion therapy, banned the gay/trans panic defense, made all single stall restrooms gender neutral, expanded services for those living with HIV, and more. Yet as I write this, transgender people are still in need of support locally and nationally. I will continue working every day for the rights, safety, and equality of all transgender, gay, lesbian, bisexual, and queer people.



REVITALIZING OUR COMMUNITY



Pop-Up Vaccine Clinics

My office worked to establish local vaccine access. When our neighborhood had no large vaccine sites nearby, I worked with the Community Boards 7 & 9, Columbia University, Morningside Retirement and Health Services, Grant Houses, Douglass Houses, and other community leaders to hold pop-up vaccine clinics that reached thousands of local residents.



Shred Event

We didn't let the coronavirus stop us from holding our popular community shred event with Senator Robert Jackson! It was a great way to see friends and neighbors, hear from local residents, and to mark the start of Spring.
