### **Fewer Cars, More Open Streets**





Among the most popular responses on our survey was a demand for fewer cars in the neighborhood so pedestrians and cyclists can safely enjoy our streets. It's been a pleasure to work with the Loisaida Open Streets Community Coalition (LOSCC) to make our community's open streets (Ave B from 6th to 14th) a vibrant place for workout classes, theater and musical performances, as well as events like the shredding event our office sponsored. I look forward to the ongoing partnership between our office and LOSCC, including introducing legislation that would enable New York City to enforce a 5 MPH speed limit on open streets.

## **Beautifying Glick Park**

One of my favorite things about our community is that when we notice a problem, we come together to address it. Alliance for Kips Bay has been a great steward of our public spaces in the northern part of the district and I was proud to join with them throughout the year to plant bulbs, clean up trash, and refurbish park furniture at Glick Park.

#### **Invest in CUNY**

I have introduced a constitutional amendment that would guarantee New Yorkers a right to a free education at CUNY, as well as prime sponsoring legislation that expands TAP, facilitates loan forgiveness for CUNY staff, and ends transcript withholding for students all across New York regardless of whether their school is public or private. I'm also a proud co-sponsor of the New Deal for CUNY to make CUNY free again. My father

was able to graduate from CUNY because of the free tuition. More New Yorkers should have that opportunity. In the FY 2022 budget we delivered over half a billion in operations and tuition assistance funding for CUNY and SUNY. Our public universities are one of New York's greatest economic equalizers. In 2023, I'm committed to advocating for our public university students and the educators that make our system run.

# **Our Legislative Victories**

I'm pleased to recap for you the bills I passed in 2022. Some have been signed already and we expect the remainder to be signed by the deadline at the end of this year.

#### **Became Law**

- Ending transcript withholding so students can advance in their education and careers (A6938, Epstein)
- Streamlining access to the Public Service Loan Forgiveness program to enable more New Yorkers to have their student loan debt forgiven (A9523, Epstein)
- Providing epilepsy patients information to stay healthy (A3298, Epstein)
- Enhancing access to job opportunities for people with disabilities (A8599, Epstein)

#### **Awaiting Governor's Signature**

- Creating the first ever regulation of the immigration bond sector to end predatory practices - The Stop Immigration Bond Abuse (SIMBA) Act (A7770, Epstein)
- Making it easier for homeowners to install electric vehicle charging stations on their property (A6165, Epstein)
- Ensuring New Yorkers mandated to attend substance use treatment programs can participate in non-religious programs (A8163, Epstein)
- Expanding access to civil legal services (A4938, Epstein)


