

Cutting the Ribbon at Ali Forney's New Drop In Center

Ali Forney has a new 24/7 drop-in center! The new location will bring Ali Forney's vital services to LGBTQ+ youth to the heart of midtown, where so many vulnerable young people end up when they arrive in New York City. Ali Forney provides transitional and long-term housing, job

readiness programs, access to healthcare, and more; life-saving services that for many will begin at the new drop-in center. I am proud to welcome the new location to my district.

LLC Transparency Act Rally

We all know that bad landlords will try any tactic to cheat and take advantage of their tenants and workers, and shady LLC's have been a favorite for years. That's why my colleague, Assemblymember Emily Gallagher, passed [the LLC Transparency Act](#) in our house this year, while Senator Hoylman-Sigal carried the bill through the Senate. I have been a strong supporter of this bill, which requires the beneficial owners of LLC's to identify themselves, making it possible to hold them accountable for their bad behavior. Last month, we held a rally to urge Governor Hochul to sign the bill into law, and help regulators hold these companies to account.

Visiting the Members of Fountain House

I visited the members and staff at Fountain House, which has a clubhouse in Hell's Kitchen. The clubhouse model, which Fountain House pioneered, is a community-based system for treating

people with serious mental illness, or SMI. Members of the clubhouse work together in community and support one another, building social relationships and skills that are often missing from typical mental illness treatments. The clubhouse model recognizes that recovery is linked to social relationships, and the positive results show a clear need to expand this model throughout our city and state to serve our fellow New Yorkers. The New York State Assembly granted over \$1 billion in the current fiscal year's budget for mental health initiatives, and I'm proud to support treatment solutions for people struggling with serious mental illness.

The Inaugural West Side Fest

Last weekend the West Side Cultural Network kicked off the inaugural West Side Fest: a thrilling day-long festival of performances, exhibitions, and other programming. The festival had more than 20 participating institutions from the west side, including Hudson River Park, the High Line, the Joyce Theater, the Shed, the Rubin Museum of Art, and more! The day included free admission to the Whitney Museum, a poetry reading on the High Line, and activities for kids at

Little Island. The festival was a fantastic success, and I'm looking forward to it becoming an annual event for the west side to celebrate our unique cultural institutions.

Seven Stories of New Rehearsal Space for the Joyce Theater!

The Joyce Theater, a mainstay of dance on the west side, has expanded to a beautiful new building in the East Village. Formerly the Boys Club, the building is seven floors of gymnasiums, dance and recording studios, and even a pool! (It's empty for now, but Councilmember Chi Ossé and I had to try it out anyway - see photo below!) The Assembly gave \$1 million towards the renovation of the building in this year's budget, so that the Joyce can install critical infrastructure, including an elevator, and improve the heat and plumbing in the building. The new building is a fantastic resource to artists, providing affordable rehearsal space and expanding the Joyce's ability to foster the art form across the city.

Muhlenberg Library Progress

The Muhlenberg Library in Chelsea has served the Chelsea neighborhood for over a century, and was closed in April 2022 to accommodate several improvement projects for the library. The projects include HVAC (heating, ventilation, and air conditioning) replacement, elevator replacement, sidewalk improvements, and an upgrade to the fire alarm system. The New York City Department of Design and Construction provided me and other colleagues with an update on the work, and I can share that the renovations are expected to be completed in mid-2024. Groovy!

Urging President Biden to Act on Climate Change

I joined many colleagues from the State Legislature in a letter to President Biden calling on him to declare the climate crisis an emergency under the National Emergencies Act. July 2023 was the hottest month ever recorded on Earth according to the World Meteorological Organization, and temperatures are expected to continue to rise. The 2023 United Nations Climate Change Conference or Conference of the Parties (COP28) is quickly approaching, where global climate policy will be determined, and President Biden should declare a climate emergency ahead of that conference to make it clear to our global partners that the United States is leading the way in this crisis.

Nearly 500 hundred neighbors and friends came together last weekend to have lunch together at Chelsea's annual Longest Table event! The afternoon was filled with joy and community, as neighbors from around Chelsea gathered to get to know each other and share a meal. The

Penn South Groundbreaking

I joined neighbors and residents from Penn South to break ground on a brand new building that is being added to the complex. The new building will include 188 units in the heart of Chelsea, 30% of which will be affordable; providing a new stream of accessible, affordable housing for dozens of middle-class families. We must take action to address the affordable housing crisis in New York City with every tool in the toolbox, and creating new supply is an important step for the Chelsea community.

Urging DOE to Act on Facial Recognition Technology

I joined Assemblymember Monica Wallace and other colleagues on a recent letter to the Commissioner of the New York State Department of Education urging her to continue the existing prohibition on facial recognition technology (FRT) in public and nonpublic elementary and secondary schools in New York State. I'm proud to sponsor A.7625 with Senator Brad Hoylman-Sigal which would prohibit the use of biometric surveillance in any place of public accommodation.

London Terrace Tenant Association Street Fair

The London Terrace Tenant Association Street Fair was postponed as a result of last

NYSHCR Climate Friendly Homes Fund

The Climate Friendly Homes Fund, a \$250M fund launched by the New York State Homes and Community Renewal and administered by the Community Preservation Corporation, is now offering 0% interest, forgivable loans and technical assistance for building upgrades that prepare existing small rental buildings to operate on clean energy.

Retrofit Scope of Work items eligible for funding include:

- Electrical service upgrades
- HVAC systems replacement with high-efficiency heat pumps
- Domestic Hot Water replacement with high efficiency heat pumps
- Additional energy conservation measures to optimize new system performance
- Systems commissioning

Affordable Connectivity Program

The Affordable Connectivity Program (ACP) gives a discount on your household's monthly broadband internet service, if you are eligible. Participating broadband providers will apply this discount to your broadband plan.

If eligible, your household can receive:

- Up to a \$30/month discount on your internet service
- A one-time discount of up to \$100 for a laptop, tablet, or desktop computer (you will need to pay a copay between \$10 and \$50)
- Only one monthly service discount and one device discount is allowed per household

How to Apply:

- Go to [GetInternet.Gov](https://www.getinternet.gov) to submit an application or print out a mail-in application.
- Contact your preferred participating provider to select an eligible plan and have the discount applied to your bill.

Note: Enrollment is not complete until the provider confirms your plan.


SAFE Disposal Event from DSNY

NYCSBS Emergency Preparedness Tools

The New York City Department of Small Business Services provides many free resources to small businesses to prepare for a variety of emergencies. For instance, the Emergency Response Unit can:

- Provide businesses with the latest emergency information on street closures, utility disruptions, security, and demolitions.
- Once the business location is declared safe by the NYC Department of Buildings and Fire Department of New York (FDNY), we can help business-owners regain access to their business location and recover their salvageable items.
- Coordinate with the NYC Police Department and other emergency responders to make sure their business location is secure and prevent losses.
- Connect businesses to local business organizations for possible relocation assistance.
- Help accelerate re-inspections, applications, and permit processes to restore business operations.
- Connect businesses to an attorney for free legal advice.

Residents who normally receive Monday recycling collection should hold their material and place recycling out at the curb, Sunday, October 15 for pick up on Monday, October 16.
