1. "Get Alarm NYC"-Any NYC resident can have a Smoke/Carbon Monoxide Alarm put in their home at NO CHARGE for either the alarm or the installation. Call 1-877-RED CROS (1-877-733-2767), then PRESS * to schedule an appointment for installation at your home.
2. When purchasing appliances look for UNDERWRITER'S LABORATORY (UL) approval. This will indicate products of the highest quality which will "turn off" before overheating.
3. Always have a box of baking soda in your kitchen! For kitchen fires on stove top or in oven

(any grease fire), baking soda will stop the fire; water will not.

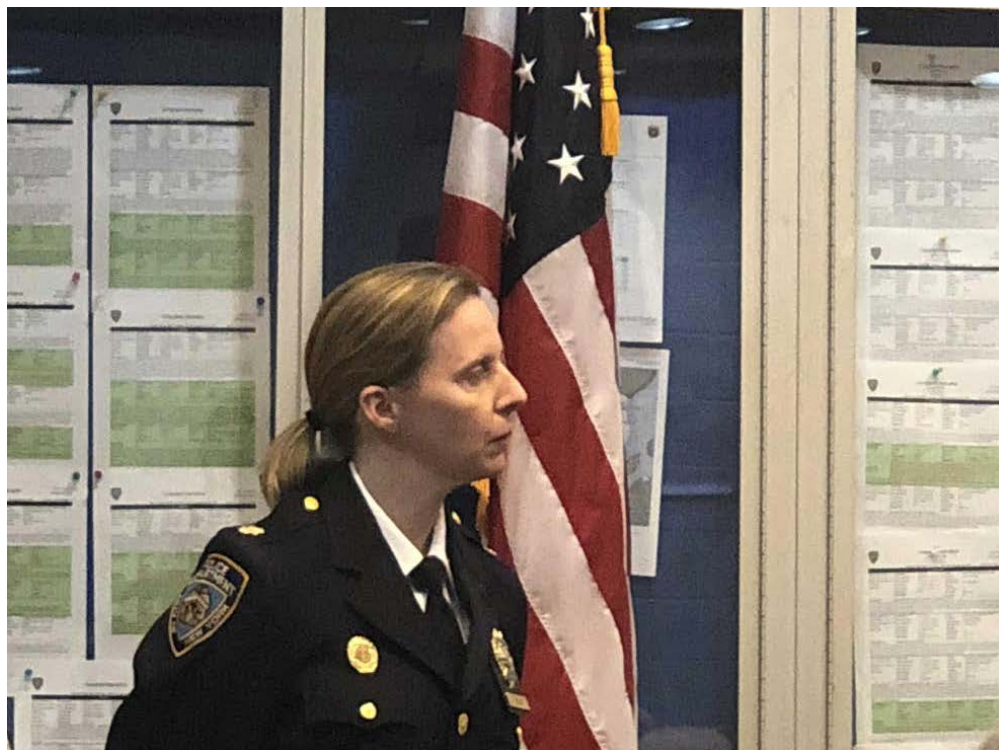

Assemblymember Rebecca Seawright Votes to Move the 2018 State Primary date to Ensure all New Yorkers can Vote

Assemblymember Rebecca Seawright (D-76th District) voted to move the 2018 state primary election date from Tuesday, Sept. 11, to Thursday, Sept. 13, out of respect for those who lost loved ones in the terrorist attacks of Sept. 11, 2001, as well as those celebrating Rosh Hashanah (A.8917-A).

“Sept. 11 will forever be a day of remembrance, a time to mourn our fellow New Yorkers whose lives were taken far too soon by an unforgiveable act of terrorism,” Seawright said. “It is also a day to honor the brave firefighters, EMTs and police officers who showed us the best of America during our darkest hours. Moving the primary election two days allows us to come together to show our respect to those who died and those who came to the rescue.”

New York State law requires that the state primary election be held on the first Tuesday after the second Monday in September. This year, that date is Sept. 11, which is also the second day of Rosh Hashanah, marking the Jewish new year. As was done in previous years, this measure recognizes and respects the significance of the anniversary of the Sept. 11 attacks and the Jewish holiday, noted Seawright.

“Voting is our most important civic duty, and each and every New Yorker should be able to exercise this right freely and equally,” Seawright said. “This legislation helps break down barriers to voter participation by ensuring that people of all faiths can get to the polls if they choose to do so.”

The Assembly has routinely passed legislation to consolidate the state’s election calendar by combining the state and federal primary election dates to the fourth Tuesday in June (A.3052). This would not only prevent the primary from falling on Sept. 11 or Rosh Hashanah in the future, but would also save taxpayers an estimated \$25 million, reduce the burden on county boards of elections and keep New York State compliant with the federal Military Overseas and Voter Empowerment (MOVE) Act. Further, holding both primaries on the same date would make it easier for New Yorkers to vote, increasing voter turnout and strengthening our democracy, concluded Seawright.

Assemblymember Rebecca Seawright Keeps the Dream alive, Co-Sponsors Bill to help ‘Dreamers’ attend College

With DREAM Act, Assembly emphasizes opportunity, diversity and compassion

Assemblymember Rebecca Seawright (D-76th District) announced that she co-sponsored the New York State Development, Relief and Education for Alien Minors (DREAM) Act to expand access to higher education for the children of immigrants (A.9605-A). This legislation will help more hardworking students earn a college degree, begin successful careers and give back to their communities, Seawright noted.

“Children should not be punished because their parents brought them here in search of a better life, making sacrifices and experiencing hardships many of us couldn’t even imagine,” Seawright said. “Let me be clear, these are children who know no other home and we are proud to have them here. We will not turn our backs on them. We will not push them into the shadows. To all ‘Dreamers’: You are New Yorkers, you are valued and you are worthy.”

The DREAM Act would give undocumented college-bound students who meet certain eligibility requirements – such as attending high school in New York – access to the state Tuition Assistance Program (TAP) and other educational assistance programs, including the Higher Education Opportunity Program (HEOP), Educational Opportunity Program (EOP), Collegiate Science and Technology Program (C-STEP) and similar programs at community colleges.

These students are already benefiting from public education from pre-K through high school and are eligible for the in-state tuition at SUNY and CUNY schools. Cutting off assistance as they venture on to the next part of their educational journey is both cruel and illogical, noted Seawright.

The bill also establishes a scholarship fund with private donations – the DREAM Fund – and expands access to the New York State College Tuition Assistance Savings (529) Program so that children of undocumented immigrant parents with a valid taxpayer identification number can set up tuition savings accounts, noted Seawright.

“Even though the federal administration is shamefully targeting ‘Dreamers’ by dismantling the Deferred Action for Childhood Arrivals (DACA) program, New Yorkers know that America was built on dreams,” Seawright said. “Expanding access to higher education for the children of immigrants is the right thing to do. They have worked hard, and they deserve every chance to soar and make this state stronger.”

ADVISORY: MetroCard Vending Machines to Undergo Software Upgrade During Early AM Hours Saturday

Machines will Accept Cash Only 12:01 a.m. – 6:00 a.m. on Feb. 10; Overnight Weekend Timing Designed to Minimize Customer Inconvenience

The Metropolitan Transportation Authority (MTA) is performing a major upgrade to software responsible for credit and debit card transactions on MetroCard Vending Machines during the very early morning hours Saturday, Feb. 10, between 12:01 a.m. and 6:00 a.m. The overnight timing of the upgrade was chosen for when ridership is at its lowest and minimizes impact on the vast majority of New York City Transit customers. All machines will be accepting credit and debit cards again beginning at 6 a.m. on Saturday, Feb. 10. This upgrade impacts all MetroCard Vending Machines, in subway stations, PATH stations, the JFK AirTrain system and at LaGuardia Airport.

New York City Transit is also launching an aggressive public outreach campaign that includes station signs, notices on the machines' screens, systemwide announcements, social media messages and direct e-mail and text alerts to customers. Customers may sign up for alerts at www.MyMTAalerts.com.

New York City Transit Subway staff in stations will help any customers with information during the system update. Customers without cash will be accommodated by station personnel during the upgrade if necessary as well. Staff will also be available with information for people who call 511 or use the "information" button on any Help Point kiosk. As always, social media staff will respond 24/7 to any customer concerns on Twitter at @NYCTSubway.

"After hearing clearly from our customers that they needed more information regarding this upgrade, we reassessed the entire process," said MTA Managing Director Veronique Hakim. "We are aggressively communicating with customers about this upgrade to ensure that we avoid confusion, and limiting the disruption to only the very early morning hours Saturday."

The upgrade is being performed centrally on mainframe computers, and is being done to further improve the reliability and security of credit and debit card transactions on all MetroCard Vending Machines, which collectively process approximately 800,000 transactions per day. Cash transactions are unaffected during the upgrade.

The MTA is currently working with the Cubic Corporation to develop a modern, world-class replacement for the MetroCard system. Over the next several years, a new system will be phased in which will allow customers to pay for rides using their own smartphones and state of the art cards linked directly to payment accounts. 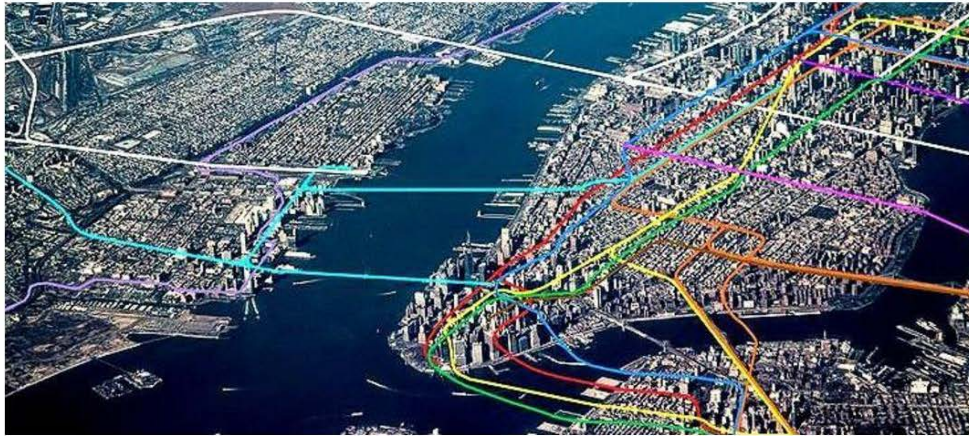

Please be advised that on Friday, February 9th - Sunday, February 11th 2018, there will be a crane lift in operation updating the emergency power system and cooling towers at Memorial Sloan Kettering. The crane lift operation will require road closures as explained in detail below:

York Avenue

Four (out of Six) lanes will be closed on York Avenue, between East 66th Street and East 68th Street, from 12:01am on Saturday February 10th until 11:59pm on Sunday February 11th (48 hours total). A single lane for northbound vehicle traffic and a single lane for southbound vehicle will be maintained on the eastern side of York Avenue for the aforementioned duration.

East 67th Street

All lanes of East 67th Street between 1st Avenue and York Avenue will be closed from 12:01am on Saturday February 10th until 11:59pm on Sunday February 11th (48 hours total).

If there is inclement weather or any other unforeseen issues which will not allow this crane work to proceed, the above closures will be shifted to the following weekend (2/16/18-2/18/18).
