*This past Legislative session I passed a resolution memorializing the governor to proclaim October as Domestic Violence Awareness Month in the State of New York. Domestic Violence is the silent pandemic with the number of cases rising throughout the COVID-19 Pandemic. On Thursday I wore purple in honor of Purple Thursday, a national day of action each October during Domestic Violence Awareness Month.*

*My office has scheduled two new COVID-19 Booster Vaccine Clinics after our first three days were completely booked. We will be hosting the vaccine clinics on November 5th and November 12th, offering the Pfizer and Moderna Booster Shots, as well as the Moderna third dose. *Tomorrow Saturday, October 23rd, is the first day of early voting in New York City. The polls will be open from 8:00am to 5:00pm. You can find your early voting poll site, which may be different from you election day site by visiting the Board of Elections website ( <https://vote.nyc/> ) or by calling 212-487-5400. Early Voting will last for 9 days with the last day on Sunday, October 31st. All polling location will re-open on Election Day, November 2nd from 6:00am to 9:00pm.*

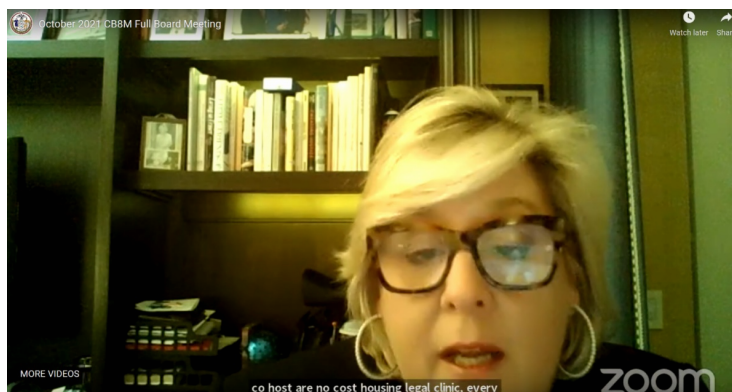

### **WHO CAN GET AN ADDITIONAL SHOT?**

#### **PFIZER & MODERNA BOOSTERS**

Those aged 65+

Those aged 18-64 who live in a nursing home or LTC facility, have an underlying medical condition increasing their risk for COVID-19, or people at increased risk of COVID-19 exposure due to their job (ex. healthcare workers) or where they live or frequently visit (homeless shelter).

#### **MODERNA THIRD DOSE**

Separate from booster shots, people who are moderately to severely immunocompromised (meaning they have a weakened immune system) are eligible for a third dose of the Pfizer or Moderna vaccine, as part of their initial vaccination series. They can get a third dose 28 days after their second shot.

### **Additional COVID-19 Updates**

Governor Hochul signed into law a *new moratorium on COVID-related residential and commercial evictions*, which is in effect until January 15, 2022.

The Open Enrollment Period for uninsured New Yorkers has been extended through December 31, 2021. New Yorkers can apply for coverage through [NY State of Health](#) or directly through insurers.

Health care workers can text NYFRONTLINE to 741-741 to access 24/7 emotional support services.

Any New Yorker can call the COVID-19 Emotional Support Hotline at 1-844-863-9314 for mental health counseling.

#### Free Transportation and In-Home Vaccinations

City residents 65 and older can get free transportation to and from a vaccination appointment. This service is also available for those with disabilities who have no other way to get to a vaccination site.

To schedule free transport by either ambulette or taxi (including wheelchair accessible vehicles), call 877-VAX-4NYC (877-829-4692). If you are younger than 18, you must have your parent or guardian call to book the trip on your behalf.
