Adult Survivors Act:

Holding Perpetrators Accountable and Promoting Justice

The Assembly Majority passed legislation to create a one-year lookback window for adult survivors of sexual crimes to bring civil claims that are barred by a statute of limitations. (A.648-A)

Seawright Cosponsors Adult Survivor Legislation Votes To Grant Sexual Assault Survivors A Fair Shot At Justice

“Sexual assault is a vicious and inexcusable crime that forces victims to contend with unimaginable physical and emotional trauma. For many survivors, the coping process is ongoing and may prevent them from ever confronting their abuser because they simply run out of time under current law. It’s crucial that our legal system acknowledges and respects this fact so victims can tell their story and pursue justice on their own terms, without a ticking clock threatening to silence them.

“The Adult Survivors Act would create a one-year ‘look-back’ window for adult survivors of sexual assault to file civil claims and hold their abusers accountable (A.648-A). It also allows for the revival of time-barred civil lawsuits based on sex crimes against victims who were 18 or older at the time of the crime. Coming to terms with this abuse can take years or even decades for victims no matter their age, and they should each be at liberty to decide when and how they want to

come forward.

“This legislation builds on the Assembly Majority’s record of standing up for and giving voices to abuse survivors. In 2019, we came together to pass the Child Victims Act to allow more victims of childhood sexual abuse to face their abusers in a court of law (Ch. 11 of 2019). As a result, more than 10,000 lawsuits have been filed and countless survivors have been empowered to share their stories. However, many individuals who were shut out of our courts due to New York’s formerly insufficient statutes of limitations have still been left without a path to seek justice. The Adult Survivors Act would finally give these survivors the chance to get justice and have their perpetrators held accountable.

“Here in New York State, we’ll always ensure victims are heard, believed and given the opportunity to seek justice. After tragically having their power ripped from them, the Adult Survivors Act will put control back into the hands of survivors and help them gain the closure they need to continue healing and moving forward.”

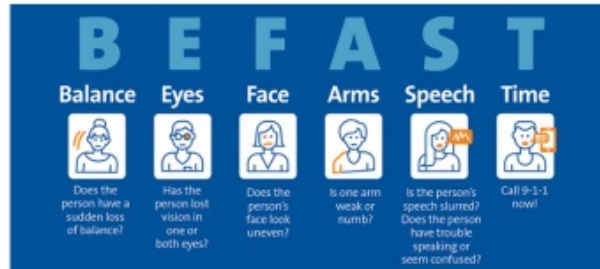
