In a big win for New York State voters, the highest court in New York, the State Court of Appeals has allowed the Equal Rights Amendment to stay on the ballot this November. I am pleased that New Yorkers will be able to decide their own future at the ballot box this November.

In July, we celebrate Disability Pride Month and the anniversary of the Americans with Disabilities Act (ADA). On July 26, 1990, the ADA was signed into law. It provides civil rights protection for people with disabilities and allows for access to state and local government services, public transportation, public accommodations, employment, and telecommunications relay services. We recognize and honor people with disabilities and the advocates who continue to fight for their rights. Included in this special report is a presentation on Neurodiversity at Work by Dr. Susanne M. Bruyère, Ph.D., CRC, Professor of Disability Studies and the Academic Director of the Yang-Tan Institute on Employment and Disability, ILR School at Cornell University.

I am proud to announce that legislation I cosponsored and strongly supported to protect New Yorkers from the harms of E-bikes and lithium-ion batteries has been signed into law by Governor Hochul. Lithium-ion battery fires and careless e-vehicle usage pose deadly threats to our communities. With the enactment of this legislative package, we secure these growing technologies and require accountable use for all New Yorkers. No one should fear navigating their own neighborhoods.

New York's Top Court Confirms the State Equal Rights Amendment will be on the Ballot in November



The voters won! They will get to decide and vote on Prop 1 - The Equal Rights Amendment this November

New Yorkers will have the opportunity to vote on a constitutional amendment to prohibit discrimination on the basis of ethnicity, national origin, disability, age, and sex, including sexual orientation, gender identity, gender expression, pregnancy, pregnancy outcomes, and reproductive healthcare and autonomy.

Assembly Member Rebecca Seawright Cosponsored and Strongly Supported Legislation Signed into Law By Governor Hochul to Protect New Yorkers from Lithium -Ion Batteries and E-bikes



Governor Hochul signed into law a legislative package to raise awareness about the safe use of e-bikes and products that contain lithium-ion batteries and protect New Yorkers. In response to recent accidents and deaths involving poorly manufactured batteries in e-bikes and scooters, this bill promotes safer methods of manufacturing, selling, and operating e-bikes and scooters, protecting New Yorkers from battery fires and collisions.

No one should fear navigating their own neighborhoods. The enactment of this

legislative package, which Assembly Member Rebecca Seawright cosponsored, will secure these growing technologies and require accountable use for all New Yorkers:

A.4938-D to prohibit the sale of lithium-ion batteries (used in many electronic devices like phones, tablets and e-bikes) that do not meet specific industry standards established by this law. These standards were designed to greatly increase the safety of lithium-ion batteries, and prevent more accidents involving e-bikes exploding due to poorly manufactured and unregulated batteries.

A.9338 to require the Department of State (DOS) to work with the Division of Homeland Security and Emergency Services (DHSES) and the New York State Energy Research and Development Authority (NYSERDA) to develop and maintain safety resources information, and protocols in regard to fire hazard prevention relating to lithium-ion batteries, second-use lithium-ion batteries, bicycles with electric assist, mopeds, and micro-mobility devices. This information aims to teach consumers and sellers how to safely handle and charge their devices, and dispose of the batteries.

A.9337 to require the State Fire Administrator within the Office of Fire Prevention and Control of the Department of Homeland Security and Emergency Services to provide training materials for first responders regarding emergency response to incidents involving lithium-ion batteries. This training will help to reduce the danger caused by lithium-ion fires by educating first responders on how to respond properly.

A.01910-B to require retailers of items containing lithium-ion batteries to provide consumers with operating manuals to educate consumers on how to best prevent lithium-ion battery explosions.

A.7628-A to require police and judicial officers investigating an accident with an ebike or e-scooter that results in death or injury to make a report to the Department of Motor Vehicles, consistent with current requirements for motor vehicles and motorcycles. The bill amends the makeup of accident reports to mention whether accidents are related to e-bikes or e-scooters. Since the recent legalization of ebikes in NYC, the government is not yet informed on the details surrounding e-bike accidents, such as where, when, and how often they occur. Now, accident reports will mention if the accident was related to e-bikes in order to collect the necessary data to work towards promoting safer e-bike usage.

A.8450-B to amend traffic and vehicle law to require limited-use motorcycles, also known as mopeds, to be registered at the point of sale. Unregistered mopeds can ride with impunity and have been the cause of various pedestrian and cyclist injuries, and this bill now ensures that riders of these vehicles are held accountable.

A.8102-A to require e-bikes and e-scooters to have a red tag attached to the charging cord which states "UNPLUG WHEN NOT IN USE". By making sure e-bike and e-scooter owners know to stop charging their vehicle once it is fully charged, this bill adds another layer of safety in an effort to prevent more fires caused by the lithium batteries.

A.8310-C to require retailers to affix a notice on any bicycles with electric assist and micro-mobility devices which states that drivers must always yield to pedestrians and follow traffic laws. This bill aims to protect pedestrians and address the increasing number of electric bicycle and scooter incidents.




