# Just Announced! Farmer's Market Coupons from the NYC Department of Aging

The Department for the Aging's Farmers' Market Nutrition Program (FMNP) is designed to provide eligible older New Yorkers with access to locally grown fruits, vegetables, and herbs. Those who are eligible are provided coupon booklets, worth \$25, which can be redeemed at participating farmers' markets, farm stands, and mobile markets. The program aims to promote improved nutrition through increased consumption of locally grown fresh fruits and vegetables, and improve sales at participating vendors.

# Eligibility Requirements:

- Sign-up at the local older adult center or congregate meal site.
- Older adults who meet the following eligibility requirements can apply for coupon booklets:
  - 60 years of age or older;
  - Earning no more than:
    - \$2,322 per month for a one-person household;
    - \$3,152 per month for a two-person household;
    - \$3,981 per month for a three-person household.

# **Senior Citizen Rent Increase Exemption**

A rent freeze for rent regulated tenants in New York City aged 62 and older with a total household income of \$50,000 or less.

# Senior Citizen Homeowners Exemption (SCHE)

Sliding Scale real estate sliding exemption of 5% to 50%.

# **HEAP** is Here to Help Make Heating Bills More Affordable

HEAP provides financial assistance to both renters and homeowners to cover the costs of electricity, propane, natural gas, wood, oil, kerosene, coal, or other heating fuels. Eligible families can also apply for funds to help pay for home heating equipment and repairs.

Eligibility for HEAP relies on several factors including income, household size, primary heating source, and whether a member of the household is under the age of 6, over the age of 60, or permanently disabled.

Applications for the 2024-25 winter season will open soon.

An extra emergency payment is also available to households that are out of fuel or going to have their service shut off. Contact the Heat Line if you are having trouble paying your utilities bill at 212-331-3150.

# Reduced-Fare and MetroCard Bus/Van

You can refill your card or buy a full range of MetroCards. Senior Citizens 65+ and people with disabilities, who have a Medicare card and a valid photo ID, such as a driver's license, can apply for a Reduced-Fare MetroCard. Reduced fare in 2024 is \$1.45.

# **Universal Rent Control Enacted**

New "Good Cause Eviction" Law Protects
Market-Rate Tenants From Unreasonable
Eviction and Rent Increases Above Defined
Reasonable Standard.

### What does the "Good Cause" law do?

It gives tenants the power to challenge evictions that are arbitrary, retaliatory, or discriminatory, as it limits landlords to only evict tenants if there is a specified "good cause." The law also protects tenants from facing hefty rent increases, as landlords must justify any rent hikes above 10%, or the consumer price index (which measures inflation) plus 5%, whichever is lower.

# What is a "Good Cause"?

You are entitled to stay in your apartment, unless your landlord specifies proof of a "Good Cause" for eviction. "Good Causes" include: breach of lease, nuisance, malicious or grossly negligent substantial damage, unreasonable refusal of access for necessary repairs, demolition, and non-payment of rent. Where a rent increase is found unreasonable, a tenant's failure to pay the increase does not constitute good cause for removal.

### Who does this law cover?

The law assumes all market-rate tenants are covered, but includes a comprehensive list of exemptions. Some notable exemptions include: Landlords with under 10 units, Owner-occupied buildings that contain 10 units or less, Units with a monthly rent that is greater than 245% of the Fair Market Rent, Condos and Coops, New housing, and Units already subject to rent regulation, like rent-stabilized units and public housing that have more robust protections for tenants.

# The NYC Rent Guidelines Board Vote 5-4 to increase rent for rent-stabilized tenants

# What is the NYC Rent Guidelines Board?

The RGB is a city body that establishes rent adjustments for approximately one million rent-stabilized apartment units. NYC's Mayor appoints all nine members: two who represent tenants' interests, two who represent owners' interests, and five who represent the general public, including one chairperson.

# What Did They Decide?

In a 5-4 vote, and despite calls for a rent freeze, the board approved rent increases for over two million rent-stabilized tenants with leases starting on October 1st, 2024.

#### **How Will This Affect Me?**

Rent-stabilized New Yorkers who sign one-year leases beginning on Oct. 1st, 2024 will face a 2.75% rent hike. Tenants who sign two-year leases will receive a 5.25% increase.

## What Can I Do?

- Find out if you are eligible for the New York City Rent Freeze Program, including SCRIE for seniors or DRIE for individuals with disabilities.

# **Supplemental Nutrition Assistance Program (SNAP)**

Monthly allotment of benefits through a debit card system for purchasing nutritious food items; dollar value depends on household size and income.

### **Eligibility:**

Based on income, family size and household composition.

#### **Income Limits:**

Monthly Gross Income for Individuals without Earned Income: \$1,580.

Monthly Gross Income for Households with Elderly or Disabled Member and Households with Dependent Care Expenses: \$2,430.

# **Lifeline Telephone Service**

Reduces the cost of basic telephone service to as little as \$1 a month.

#### **Eligibility:**

Persons with an income at or below 135% of the Federal Poverty Guidelines or who are eligible to receive assistance benefits from at least one of these programs: Medicaid, SNAP, SSI, HEAP, Section 8, Veterans' non-service-related Disability Pension and Veterans' Surviving Spouse Pension, TANF or Head Start.

# Access-A-Ride (AAR)

Provides transportation for people with disabilities who are unable to use public bus or subway service for some or all of their trips. It offers shared ride, door-to-door paratransit service. Provides "feeder service" – trips to and from fixed-route MTA NYC Transit bus stops – for people able to walk or wheel between 1 and 5 blocks. MTA NYC Transit administers AAR; private carriers under contract to NYC Transit to provide service.

### **Eligibility:**

Disabled riders. Eligibility is determined on a periodic basis, after review by independent medical professionals in consultation with disabled riders' medical provider.

# School Tax Relief (STAR) Exemption

Note changes to the program: For those who have already received Basic and Enhanced STAR, eligibility and application requirements will remain the same. New applicants will receive an income tax credit via a check-off box on the New York State income tax return instead of an exemption. A separate form will be available for those who are not required to file taxes.

Note for Basic STAR only: All homeowners receiving a Basic STAR exemption must register with the New York State Tax Department in order to receive STAR exemptions.

#### Benefits:

Provides property tax exemption (also known as the homestead exemption) for all NYS homeowners.

### **Eligibility:**

Must own home (includes one-, two- and three-family homes and home must be primary residence). *Enhanced STAR:* Persons who are 65+ by December 31 of the year in which the exemption will begin.

#### **Income Limits:**

Basic STAR: \$500,000 or less combined household income. Enhanced STAR: \$84,550 or less for all owners, and owner's spouse residing at property.
