

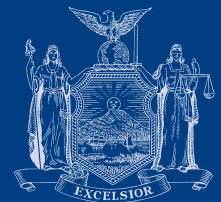
Amy Paulin continues to be one of the most productive members of the New York State Assembly.

Amy Paulin sponsored 33 bills in 2014 that passed the State Assembly and 21 of those passed both houses of the State Legislature – this is the 2nd most by any member of the State Assembly.

Amy Paulin's recent victories for the people of New York State:

Ch. 374: Helps keep property taxes down by saving school districts money. BOCES will be allowed to enter into 20-year lease agreements instead of 10-year agreements and BOCES lease payments will now match State reimbursements.

Ch. 367: Saves local governments and school districts money by allowing them to post bids on a statewide website. Costs will be reduced by attracting an increased number of bidders which will lead to increased competition and lower bids

Ch. 402: Ensures that human trafficking victims who are 16 and 17 years old will now be treated as victims instead of criminals and get the services they need.

Ch. 385: Requires the court to waive any mandatory surcharge and crime-victim fees for sex trafficking victims. Imposing the surcharge and fee likely means the victim's trafficker will pay the amounts required, pushing the victims right back into the hands of the trafficker.

Ch. 205: Requires athletic coaches to report cases of child abuse. Coaches are in a unique position when it comes to gaining a child's trust. He or she would often be in a position to spot abuse and therefore should be required to report it rather than remain silent and uninvolved.

Ch. 193: Makes it a crime to record and share images of sexual acts without the knowledge of the participant.

Ch. 534: Mandates that the Freedom of Information Law and New Jersey Open Public Records Act apply to the Port Authority.

Ch. 518: Assures parity between fuel cells and other clean energy technologies.

Ch. 420: Allows healthcare providers who administer immunizations to access the statewide immunization system and requires they report immunizations of consenting adults, avoiding duplicate immunizations.

A6974/S7839: Recognizes the service of all of our veterans by allowing them to purchase up to three years of service credit in the state public retirement systems.

A7896/S5500: Authorizes a municipal energy aggregation pilot program in Westchester County, which allows municipalities to pool together residents and solicit bids from energy services companies to supply their electricity and gas. This will save customers money and provide flexibility for the municipality to buy energy produced from alternative sources.
