

Amy Paulin's recent victories for the people of New York State include:

Preventing Gun Violence

- **Preventing gun violence** by prohibiting the sale, purchase, or transfer of firearms to anyone known to have an outstanding warrant (A.6198B/S.5000B) and informing patients of mental health facilities about the State's "Red Flag" law which allows guns to be temporarily seized from people believed to pose a danger to themselves or others (A.1005A/S.5434A).

Improving Healthcare Access

- **Improving healthcare access** by authorizing optometrists to prescribe certain medications for conditions such as glaucoma that require immediate attention (A.1921/S.1519).

Fighting Human Trafficking

- **Fighting human trafficking** by exempting victims of sex trafficking from the requirement to provide a DNA sample for inclusion in the state DNA identification index (A.118B/S.6185A).

Supporting Early Intervention

- **Supporting Early Intervention** services for children by improving reimbursement to providers (A.5339/S.5560A).

Strengthening Utilities' Storm Response

- **Strengthening utilities' storm response** by requiring the creation of dedicated storm hardening programs and reimbursing customers following prolonged power outages (A.3360A/S.4824A).

Preventing Robocalls

- **Preventing robocalls** by mandating that providers block "spoofed" phone numbers (A.268A/S.6267A) and implement technology to authenticate calls (A.585A/S.4281A).

Increasing Government Transparency

- **Increasing government transparency** by opening more meetings to the public (A.924A/S.1625A), requiring meeting minutes to be posted online (A.1108A/S.4704A), and requiring documents to be posted online 24 hours prior to a meeting (A.1228A/S.1150A).

Ensuring Fair Redistricting

- **Ensuring fair redistricting** by requiring all counties and local governments in New York to follow set standards (A.229C/S.5160B).

Repealing Discriminatory Crimes

- **Repealing the discriminatory crime of "loitering for purposes of prostitution"** which was used to unfairly target transgender people (A.3355/S.1351).
