

Amy Paulin's recent legislative victories for the people of New York State include:

Preventing Gun Violence

- Implements enhanced safety and security measures at gun stores and requires law enforcement to report seized and recovered guns to the state criminal gun clearinghouse, as well as the federal criminal gun and ammunition databases (Ch. 207 of 2022).

Protecting Reproductive Rights

- Allows reproductive healthcare providers, employees, volunteers, and patients to keep their address confidential (Ch. 222 of 2022).

Fighting Human Trafficking

- Requires human trafficking informational signs or cards to be placed in restrooms at Port Authority airports (Ch. 388 of 2022), Port Authority bus terminals (Ch. 390 of 2022), Thruway service areas (Ch. 394 of 2022), truck stops (Ch. 391 of 2022), and commercial airports (Ch. 389 of 2022).
- Mandates human trafficking awareness training for hotel employees (Ch. 393 of 2022).
- Directs the Port Authority Police Department to operate youth services units to address youth trafficking and homelessness at their facilities (A.9968/S.8907).

Increasing Government Transparency

- Prohibits public agencies from charging a fee for requests for records under the Freedom of Information Law when an electronic copy of the record is already available (A.4677A/S.4863A).
- Requires the commissioner of the Office of General Services to compile, make public, and keep current information about state boards (A.843A/S.8145).
- Makes election district maps available to download online (A.831A/S.4591A).

Keeping Children Safe and Healthy

- Prevents child deaths from overheated vehicles by requiring warning signs and selling car seat alarm devices in stores (A.381A/S.300A).
- Ensures that all summer camps check the national and state sex offender registry for all potential employees and volunteers (Ch. 248 of 2022).
- Expands workplace accommodations for breastfeeding employees (A.1236A/S.4844B).

Expanding Voting Rights

- Safeguards the right of absentee voters to have their votes counted when there are stray marks on the ballot (Ch. 228 of 2022).

Preventing Nuisance Calls

- Requires telemarketers to give customers the option to be added to the do-not-call list in the beginning of the call (A.8319C/ S.8450B).


