

Amy Paulin's recent legislative victories for the people of New York State include

Protecting Reproductive Rights

- Enacts the Birth Control Access Act, allowing pharmacies to both provide a prescription and dispense birth control at the same time, increasing birth control access (Ch. 128 of 2023).

Fighting Human Trafficking & Sexual Assault

- Requires human trafficking informational signs or cards to be placed in lactation rooms at Port Authority Airports (Ch. 490 of 2023), Port Authority bus terminals (Ch. 495 of 2023), Thruway service areas (Ch. 494 of 2023), truck stops (Ch. 492 of 2023), commercial airports (Ch. 493 of 2023), and MTA terminals (Ch. 491 of 2023).
- Aids rape victims by creating a statewide electronic evidence collection (rape) kit tracking system (Ch. 31 of 2023).
- Protects women by making it a crime to disseminate "deepfake" intimate images created using AI (Ch. 513 of 2023).

Keeping Children Safe

- Increases the age that children can operate ATVs from 10 years old to 14 (Ch. 539 of 2023).
- Ensures that all summer camps check the national and state sex offender registries for all potential employees and volunteers (Ch. 530 of 2023).
- Strengthens school safety by requiring school districts to consider incorporating designs for healthier and more secure school facilities (Ch. 529 of 2023).

Safeguarding Health

- Enacts the Lead Pipes Right to Know Act requiring public water systems to inventory service lines and make the information public (A.6115/S.5512).
- Expands "Community Paramedicine" allowing paramedics to continue providing the additional services they provided throughout the pandemic, serving the needs of the elderly and immunocompromised (Ch. 137 of 2023).
- Requires glucose-6-phosphate deficiency testing for all newborns (A.7338/S.6542).
- Allows public health clinics to more easily continue to serve communities with less red tape (A.2400/S.6219).

Protecting Consumers

- Requires sellers to clearly post the price of any credit card surcharge they are charging (A.2672b/S.1048a).
- Requires the consumer protection division to establish a model notice of potential scams when selling gift cards (Ch. 47 of 2023).
- Prohibits medical debt from being collected by a consumer reporting agency or included in a consumer report (A.6275a/S.4907a).
- Requires businesses to notify consumers of an upcoming automatic renewal or continuous service charge thirty days prior to such charge (A.3245d/S.5941b).

Expanding Voting Rights

- Ensures that absentee ballots are counted despite something inconsequential like a piece of tape on an affirmation envelope (Ch. 472 of 2023).
