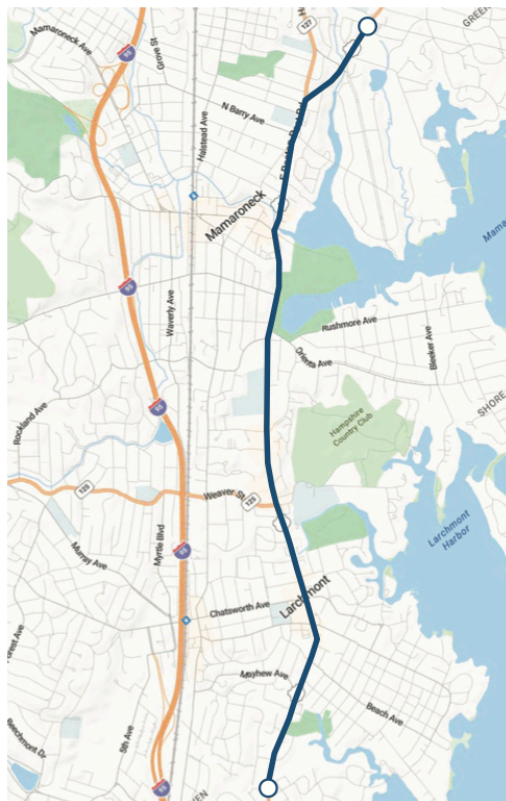

The New York State Department of Transportation (NYSDOT) will host an open house to gather input about future improvements to the U.S. Route 1 corridor in Mamaroneck and Larchmont.

The goal of this meeting is to identify alternatives that will enhance safety for the traveling public, promote active transportation, and support pedestrian and bicycle transit.

The project limits are along U.S. 1 from Dillon Road to Hornidge Road.

Since the January of 2024, Senator Mayer and I have been working together on plans for improvements on the Boston Post Road corridor, a state road, with the

NYS Department of Transportation (DOT). The U.S. Route 1 Complete Street project falls within the Village of Mamaroneck, Town of Mamaroneck, and Village of Larchmont.

Last July, we organized an initial meeting with the DOT and municipal officials along the Route 1 corridor to ensure that the public participation process is set-up to involve everyone, and to make sure all suggestions are heard from the three municipalities and two school districts to help determine the mix of safety improvements along this corridor.

In November 2024, the DOT held its first Stakeholders Meeting in Mamaroneck and heard initial feedback from the municipal officials, school superintendents, and Safe Route to School representatives on what pedestrian safety, traffic calming, and safe route to school modifications would be ideal to include on the Boston Post Road corridor. Based on these recommendations, the DOT and its consultant will present their initial designs at the Open House on June 5th and parents and community advocates can share their comments and provide further feedback regarding pedestrian safety measures that can be incorporated into the Route 1 project.

Our long-standing commitment remains to work with every level of government to improve traffic and pedestrian safety infrastructure. The NYS DOT is also ready to work with these three municipalities and the two school districts on any short-term requests that they feel needs to be addressed while the major project is advancing.

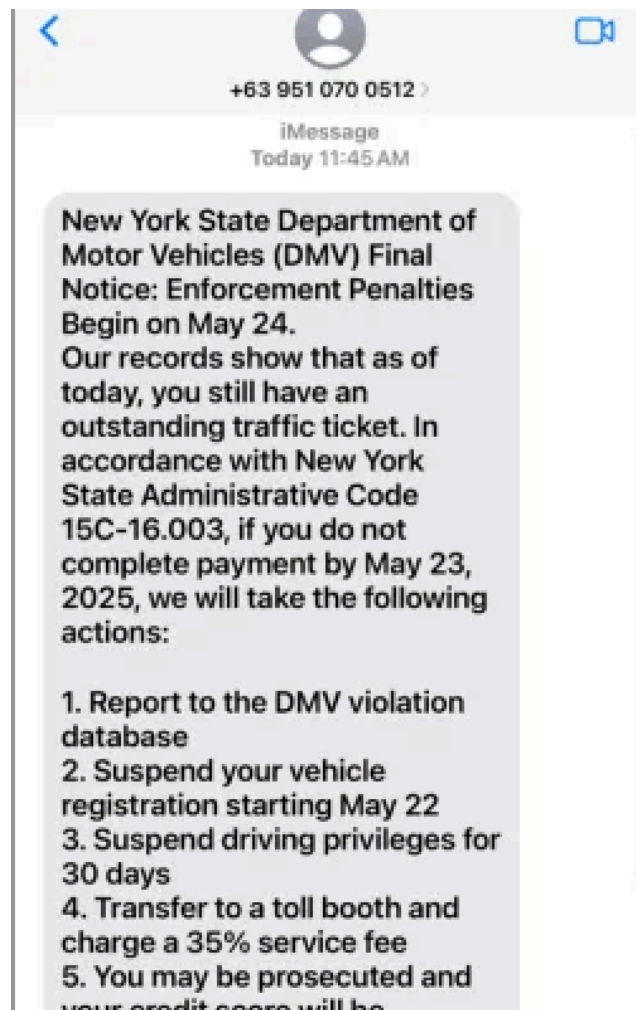

### **DMV Text Message Scam**

A recent phishing scheme pretending to be the state DMV is affecting residents in several areas. The text will warn of an outstanding traffic ticket with a payment deadline and a number of consequences, including the suspension of your registration and driving privileges, if payment is not made.



Earlier this year the Thruway Authority also warned drivers of an EZ pass scam with similar language.
