COVID-19 Update - 109th Assembly District

The last few weeks and months have been both extraordinary in terms of the disruption COVID-19 has suddenly caused to our lives, and tragic as New York continues to bear the brunt of the national outbreak. Despite this, the state government and legislature continue to respond to the needs of New Yorkers, including right here in the Capital Region. Early on in this crisis, the legislature enacted Paid Sick Leave for those affected by COVID-19 and appropriated \$40 million in immediate emergency funds. Shortly thereafter, facing a large revenue shortfall compounded by COVID-19, we passed a state budget that included expanded unemployment insurance (UI) benefits for COVID-19 affected workers, the Environmental Bond Act, a ban on flavored e-cigarettes, and a host of other accomplishments.

Recently, I've co-hosted several weekly virtual town halls with my colleague Assemblymember John McDonald that have brought experts and professionals directly in conversation with constituents on a variety of COVID-19 related issues. I've worked to ensure that my office is communicating timely updates, information, and resources to constituents in order to keep you apprised of the most critical updates through our regular emails and social media. Several of you have already used my office as a resource throughout this crisis and I encourage you to do so with any questions you might have regarding unemployment insurance, job and career resources, small business assistance, SSI or federal stimulus payment help, and more, at the contact info on page 3. I am honored to represent each of you in the New York State Assembly and I look forward to navigating this crisis together as we work to ensure the Capital Region's communities and economy rebound from this crisis stronger than ever before.

# Our Push for a 21st Century– Works Progress Administration (WPA)

Two dozen of my colleagues in the Assembly signed my letter to New York's Congressional Delegation, urging them to include a new, modernday WPA jobs program as part of their priorities in upcoming stimulus legislation or future recovery strategies. In an op-ed published by The Altamont Enterprise ('The Case for a 21st-Century WPA – We Must Be Bold As Well As Practical') and the Albany Business Review ('It's Time for a New Works Progress Administration'), I urge for a return to what worked in the 1930s and to launch an immediate, short-term 21st-Century WPA. Over 1.5 million people in New York State are out of work, and the United States economy is in disarray on a scale that our nation has not seen since the 1930s. Let's establish a new WPA in the next federal stimulus package without delay and focus on millennials as they are bearing the brunt of the economic fallout. I will continue to push for such an initiative as we continue to discuss the next steps on the road to what must be a smart and broad economic recovery. I've introduced legislation (A.10480/ Fahy) on this as well as the WPA-Pandemic Recovery Act, sponsored by Senator Rachel May in the state Senate.

#### Unemployment Insurance

In March, I joined my colleagues in expanding critical unemployment insurance (UI) benefits to workers affected by COVID-19 through job loss, quarantine, or other variables, to provide working families with critical financial assistance. To apply for UI benefits, call 1-888-209-8124 or visit labor.ny.gov/unemploymentassistance.shtm. The federal CARES Act provides enhanced UI benefits and Pandemic Unemployment Assistance (PUA) for New Yorkers, including an extra \$600/week in benefits. #### Federal CARES Act

Part of the federal stimulus package passed this year authorizes recovery checks for U.S. taxpayers, which are being sent out now. If you have not received your check, visit www.irs.gov/coronavirus/economic-impact-payments.

#### Small Business Assistance

Small business is the backbone of our communities. I will continue to advocate for additional small business relief from the federal government with my colleagues in the state legislature moving forward, and encourage you to support our local small businesses now more than ever. Small businesses are eligible for \$33.8 billion in emergency loans to help retain employees through the Paycheck Protection Program (PPP).
