
### **Pro-Sportsmen Legislative Initiatives**

I know how much Upstate New York depends on hunting, fishing, and other outdoor sports, and one of my top priorities is to protect this industry.

For this reason, I support the following legislative proposals to support and protect sportsmen and firearm owners in New York State:

- A.2960 will allow individuals to register to vote when applying for a hunting or fishing license.
- A.3056 will create a junior big game hunting license for young adults.

- A.5594 will authorize county clerks to make pistol license amendments.
- A.6388 eliminates the failed CoBIS ammunition tracking program, which has cost taxpayers \$36 million and not solved one crime.
- A.1154 would expand Real Property Tax exemptions for otherwise qualified individuals who create forest land habitats that will support game species.
