## IMPROVING HEALTHCARE FOR ALL WOMEN

- Passed Shannon's Law requiring all health insurance carriers to cover annual mammograms for women ages 35+ (S.3852-A)
- Expands coverage for eating disorder treatment (A.1619)
- Expand Opioid Treatment Medication Coverage under Medicaid (S.5935-A)
- Medicaid reimbursement for Complex Rehabilitation Technology to ensure access to important care (A.7492)
- Improve access to substance abuse treatments by removing pre-authorization for substance abuse treatment prescriptions (A.2904)



## QUALITY HEALTHCARE FOR MOMS

- Improve access to lactation counseling services (S.3387)
- Develop obstetric hemorrhage protocols (A.6962-A)
- Require hospitals and birthing centers to share information about pregnancy complications and provide a referral list of services (A.2957-A)



## HELPING VETERAN WOMEN

- Reduce stigma around veteran mental health and substance abuse disorder issues and provide information on treatment and services (Chapter 378)



## PROTECTING WOMEN

- Criminalize Revenge Porn (A.5981, Chapter 109)
- Help Domestic Violence Victims by requiring the state to work with hospitals to help them better identify and offer assistance and services to those who may be victims of domestic violence (A.2850-A)
- Secure Access to Justice for Sexual Assault Victims by extending the statute of limitations for sexual assault victims (Chapter 315)

## CLOSING THE PAY GAP

- Brian voted for the law improving Equal Pay in New York (S.5248, Chapter 93) and for fair compensation (S.456-B)
