Gift Card Scam Alert!

We have heard about an uptick in gift card scams in our area. Recently a constituent contacted our office about their a scammer calling them, claiming to be a federal investigator. When scammer was asked for proof of identity, they supplied a convincing image of a badge and an ID number. They presented the constituent with an urgent scenario that could only be taken care of by immediate action that included the purchase of gift cards.

REMEMBER - legitimate businesses do not ask for payments in the form of gift cards. They will not call, email or text this type of request. If you get such a request, please notify the police.

If you are the unfortunate victim of such a scam you should:

- Contact the retailer that issued the gift card
- File a report with your local police
- Report the fraud to the Federal Trade Commission

Income Tax Return

We know that many New Yorkers are facing increased financial burdens related to the pandemic. My team and I want to make sure you are taking advantage of all of the tax benefits available to you. To get started on your income tax return, check your refund status or find free assistance, visit <u>https://www.tax.ny.gov/pit/efile/</u>.

Free File can help you claim valuable tax credits without the cost of hiring a paid tax preparer. The software provides savings as well as puts money directly in your pocket by ensuring you claim the credits you deserve, including the earned income tax credit (EITC).

Earned Income Tax Credits are worth up to \$9,083 for a family with three or more children

EITC is a refundable credit for working taxpayers who earn less than \$57,414. This means you get a refund even if the credit amount is more than what you owe in taxes. <u>More info here!</u>
