Investment in Tompkins County


Last week there were some exciting announcements made about important investments in Tompkins County economy and infrastructure. Menlo Microsystems will be investing \$50 million into retrofitting a microelectronics

plant in the Village of Lansing which will bring new jobs and opportunities into our district. Our region is home to exceptional colleges and universities, and this is a great opportunity to attract and retain graduates in New York with in-demand, high-skilled jobs. Additionally, the Governor's office announced \$9.66 million in funding to replace six bridges throughout Tompkins County:

- North Cayuga Street bridge over Fall Creek in the City of Ithaca
- Town Line Road bridge over Lick Brook in the Town of Ithaca
- East State Street culvert in the City of Ithaca
- Midline Road culvert carrying the tributary to Six Mile Creek
- Curry Road culvert in Ulysses
- Lee Road culvert in Dryden

Fighting for upstate bridge replacement funding was a critically important part of this year's state budget negotiations.
