In the past days, weeks, and months, I've enjoyed the opportunity to work with my colleagues in the New York State Legislature - Senator Lea Webb and Senator Rachel May - to pass legislation borne out of the needs of our constituents in Central New York, the Finger Lakes Region, and Southern Tier.

I share legislation with Senator May on the safety of our drinking water and the health of our lakes - a keystone in New York's tourism industry. We also continue to work together in passing legislation to ensure safe, affordable, and accessible housing. These bills will provide help and protection for those both in and beyond our region.

It is such a pleasure to work with Senator Lea Webb in bringing home legislation that improves life across our shared district. On Saturday we stood together in bringing voice to our constituents' needs as well as in celebrating Voting Rights.



Sign the Carshare Bill Press Conference



Senator Lea Webb and I, along with City of Ithaca and Tompkins County legislators, and community advocates, held a press conference this weekend on the Ithaca Commons. We called on Gov. Hochul, without delay, to sign the Carshare bill which was passed by both the Assembly and Senate (A5718B/S5959B). Since Ithaca Carshare paused its operations on May 19, 1,500 local members have been without access to 30 vehicles for their transportation needs, and staff have been furloughed. Ithaca Carshare is now at risk of closing permanently if this bill isn't signed right away. If you would like to add your voice, Ithaca Carshare has compiled this helpful resource in writing advocacy emails or letters to the Governor's office.

Transportation continues to be one of the greatest contributors of greenhouse gas emissions. One of the solutions to combating

transportation's impact on climate change, identified by NYSERDA, is community carsharing and the electrification of carshare fleets. To keep carshares as viable transportation options, the organization needs to secure car insurance. This bill would not only benefit nonprofit carshares, but also

Applications Now Open for \$500 million in Child Care Workforce Grants

Childcare staff are among New York's most essential workers. To help them thrive, New York State is providing retention and referral bonuses for existing staff and sign-on bonuses for new workers ranging from \$2,300 to \$3,000 for those in caregiving roles. From Southern Tier AIDS Program: MPox Vaccination Clinic

In response to recent developments regarding MPox (formerly known as monkeypox), a crucial vaccination clinic has been organized to safeguard the health and well-being of the community. The MPox Vaccination Clinic, hosted by the Southern Tier AIDS Program (STAP), will take place on **Friday, August 11 from 12 - 4:00 p.m.** at 314 W. State St., Ithaca, NY 14850.

MPox is a serious infectious disease that demands our attention and proactive measures. With Tompkins County having the highest number of MPox cases in the Southern Tier, it is imperative that people of Ithaca are vaccinated against the virus. The vaccination clinic will provide individuals with a much-needed opportunity to receive the first shot of the two-dose MPox vaccination. A follow-up clinic for the second shot is scheduled four weeks later to ensure comprehensive protection.

Please bring your identification, if available, to facilitate the vaccination process. You can <u>pre-register</u> and walk-ins are also available.
