It has been an exciting and productive week in the district and across the state. I presented conference sessions at the New York State Association of Reduction, Reuse and Recycling conference in Cooperstown as well as the Clean Energy Summit in New York City. Back in our district, I met with stakeholder groups to discuss the Fashion Act and my EMS funding bill.

I was honored to end my week with the Varna Volunteer Fire Company at their annual banquet and present an official Assembly Citation to Roy Rizzo, recognizing 50 years of outstanding volunteer service!



Governor Signed Clean Slate into Law

I was thrilled to be able to be present in Brooklyn on November 16 when Gov. Kathy Hochul signed the Clean Slate Act into law. Clean Slate

allows for automatic sealing of criminal records from public access three years after conviction or release from jail for a misdemeanor and eight years after conviction or release from prison for a felony – provided individuals have maintained a clean record and are no longer on probation or parole. New York is safer when people have stable employment and housing. The law will remove the burden of permanent criminal records that hold individuals back from accessing housing, education, and employment, which has disproportionately impacted our brown and Black communities and contributed to generational poverty. Business and labor unions supported Clean Slate since they recognized that the law will strengthen our workforce and economy, creating jobs and filling the labor gap. New York State Association for Reduction, Reuse and Recycling Conference

I was honored to be a keynote speaker with NYS Senator Brian Kavanagh at the annual New York State Association for Reduction, Reuse and Recycling Conference. Sen. Kavanagh focused on Extended Producer Responsibility, and my presentation focused on building deconstruction in New York. Deconstruction is the systematic dismantling of buildings, roadways, and other infrastructure to maximize the salvage of valuable materials. Deconstruction, rather than demolition, reduces emissions since you need to manufacture less new materials and reduces the flow of materials into landfills.

According to the New York State Solid Waste Management Plan, NY produces 42.2 million tons of waste annually, and 46% is from construction and demolition materials. While NY does recycle some construction and demolition materials, we still landfill too much, and our landfills are quickly filling up. As one of the largest economies in the world, New York can build the needed infrastructure to spearhead the establishment of a truly circular economy. I look forward to introducing legislation that encourages the infrastructure, marketplace, and workforce development needed to develop a circular economy. Thank you to the conference organizers and to all the waste management professionals who engaged in this discussion.



New Bills to Track

New Legislation to Protect Cayuga Lake and Require Full Environmental Review for Salt Mining Permits

Cayuga Lake is a critical resource for our area, providing drinking water for over 100,000 residents and serving as the bedrock of our region's \$3 billion, 60,000-employee food, wine and recreational tourism economy. Cargill, Inc. has been mining salt under Cayuga Lake for decades, which is inherently dangerous, and any mining accident could permanently jeopardize the health of our drinking water. While the Mine Safety and Health Administration has been able to inspect the operation for worker safety, the Department of Environmental Conservation (DEC) has not regularly inspected the mine for issues related to protecting the Cayuga Lake ecosystem. After decades of mining by Cargill, Cayuga Lake is saltier than nearly all the other Finger Lakes.

I've introduced new legislation (A8520), sponsored by Sen. Lea Webb in the Senate, that requires any future mine permit approval, sale or transfer to include a full environmental review as well as a reclamation plan with appropriate financial security. While the bill does not call for the mine's closure, it does call for a prompt, public, state-confirmed review of the health of the mine in order to protect Cayuga Lake as well as the communities and jobs that depend on it.

Community Resources

Accessing Shelter during Freezing Weather

As the temperatures drop, it is important for the community to be aware of the warming centers, shelters, and resources in the district to be able to refer residents in need. A <u>recent Ithaca Voice article</u> highlights resources available in Tompkins County as well as New York's "Code Blue" policy, requiring local social services districts to provide shelter regardless of income, sobriety, or citizenship status when temperatures drop below freezing. The best way a person can quickly access housing or other information in both Tompkins and Cortland Counties is to dial 2-1-1. Throughout the winter season in Cortland County, individuals can access the warming centers at the Salvation Army or Grace and Holy Spirit Church.

CODE BLUE Warming Center

The Warming Center is a warm, safe place for individuals to go and stay overnight during the cold weather season.

This is a **free**, voluntary program that requires **no eligibility determination** and available to any adult who seeks assistance for a place to stay.
