I spent Veterans Day at the American Legion Dunbar Post 1642's annual flag retirement ceremony, and celebrated as Spectrum presented a check to the Dunbar Post for renovations to their building.

Altamont House Veterans Housing Grand Opening

On Nov. 14, I attended the Grand Opening of Altamont House Veterans Housing. This newly renovated facility will provide much-needed transitional housing to homeless veterans.









National Policy

NCOIL Annual National Meeting

From Nov. 16 through 19, I was in New Orleans for the National Council of Insurance Legislators' (NCOIL) Annual National Meeting. NCOIL is a legislative organization focused on educating state lawmakers on insurance issues and improving insurance legislation nationwide.

This year, I was honored to be elected treasurer of this valuable organization. As an active member of NCOIL for five years, my greatest achievement remains what I've been able to do as chair of the Health and Long-Term Care Committee. As the first African American woman elected as an officer in this organization, I look forward to sharing my diverse viewpoint and years of experience helping to make fair insurance policy.

One of my latest pushes in this organization is to adopt model language that will provide for greater insurance coverage of "biomarker" based medicine. As medical science advances, the resources available for illness prevention and treatment have greatly increased. With current testing, treatments can have an individualized approach based on the specific biology of a patient. Certain gene expressions, for example, can be detected and considered for particular ailments. Should my model bill pass at NCOIL, it will become much more likely that coverage for biomarker testing will become available across the country.

Legislative Updates

2022 Enacted Legislation

December 2022 saw some of my final bills that were pending approval from the Governor get signed into law. Bills benefitting veterans, our local small businesses, our fire departments and those in need of social services have all been enacted after receiving the support of both houses and final approval from the Governor last year. Some highlights include:

 A3582-A: Permanently extends the time period to access New York's courts because of exposure to Agent Orange during the Vietnam War. While the time period where exposure occurred is fixed, complications were slow to emerge, and some complications are multi-generational. My bill removes the sunset of this law to ensure all veterans of this era can pursue compensation for exposure.

• A5817-A: Requires social service offices to post a list of all services available to consumers/applicants. Social services can sometimes be difficult to navigate. The new law puts certain commonly needed services on an easy to read list that's visible in social service offices. While information can be found online, those accessing services are more likely to have reduced internet access.

 A8715: This bill was also enacted to benefit our veterans. This new law improves the reporting of veteran suicides and allows our policies to be more informed so that we may better prevent these daily tragedies.

• A10237: This is a routine but important bill. This bill allows the Salina Consolidated Fire District to recruit more members from

outside of its boundaries. While well intentioned, residency requirements for firefighters are becoming harder to comply with given the current labor environment. These exemptions are vital to keep well-staffed departments for public safety.

Named Chair of the Banking Committee

State Assembly Speaker Carl E. Heastie appointed me to chair the Assembly Committee on Banks. Since joining the state Assembly, I have sponsored and co-sponsored numerous pieces of legislation that protected consumers, supported small businesses, improved employment opportunities and lifted people out of poverty.

While the banking environment has changed significantly, with the broader adoption of cryptocurrencies and the legalization of cannabis, I look forward to taking on these challenges as chair of the Banks Committee.

As a member of the Insurance Committee, I've worked with the state Department of Financial Services (DFS), industry representatives and our communities on financial issues. Many of our communities are underserved, with limited branch hours and access. I'll work with my colleagues and the many stakeholders within this space to make our banks more accessible and turn these new challenges into opportunities.

Exceptional Women of CNY

I will host my annual Exceptional Women of CNY ceremony on May 6 at the Liverpool Library's Carman Community Room at 11 a.m.

During the month of January, I conducted a survey on various issues and legislation to hear what is most important to my constituents. This feedback will help me immensely during this year's legislative session as I advocate for resources and measures that support our region. I'm focused on keeping our communities safe, supporting local businesses and putting money back into the pockets of Central New York families.
