The Assembly is working on three pieces of legislation that are of importance to the Central New York Community. I invite everyone to contact my office at 428-9651 or at magnarw@assembly.state.ny.us to give me their opinions on each of these pieces of legislation.

• Millionaire's Tax

(A7802) - This legislation would protect working families by keeping millionaires in their current tax bracket, instead of moving them to the same tax bracket as families of four making \$40,000 a year. This proposal would affect less than one percent of tax payers and ensure that the richest New Yorkers share the burden instead of getting a tax break. Thirty-percent of the revenue gathered through the "Millionaire's Tax" would go to the Educational Assistance Fund to be distributed to struggling school districts.

• Ads on Exterior of School Buses

(A7701) - This legislation would allow boards of education to enter into contracts for the lease or sale of advertising on the exterior sides of vehicles owned or leased by the school district. The legislation prohibits advertising of tobacco or alcohol products or for political advocacy, in addition to any other advertisement products or services that the school board or commissioner deems inappropriate.

At a time when our school districts are facing unprecedented cuts in education funding, we need to look at alternative means for bringing in revenue. Some states, including New Jersey, have enacted laws allowing ads on school buses. Selling or leasing advertising space is a creative way to allow school districts to raise revenue to support important scholastic activities.

• Payment of Taxes in Installments (A6719) -

This is a bill I sponsored to amend the real property tax law to allow property owners to pay their tax bill in smaller installments. Currently, if a bill is to be paid in installments, the first installment must be at least 50 percent of the total. In these economic times, allowing the installments to be smaller would lift a burden off many tax payers. The flexibility of the bill would allow tax collectors to accept payments from taxpayers rather than turning them away if the payment was not high enough.



• Senator Kirsten Gillibrand

recently visited Syracuse to help promote the Urban Jobs Act of 2011. The legislation which she is sponsoring would amend the Workforce Investment Act of 1998 to authorize grants for national nonprofit organizations to create programs to help prepare youth for entry into the job market.

"Central New York would greatly benefit from funding that creates programs to prepare youth for entry into the job market by offering educational opportunities that lead to employment," said Assemblyman Magnarelli. "I support Senator Gillibrand's efforts with the Urban Jobs Act of 2011. Helping youth who are unemployed understand the needs of the ever-modernizing workforce will create a more stable local economy."
