### A Lifeline in Syracuse and Onondaga County and Surrounding Counties is being threatened

The recent announcement by CENTRO of the potential cuts in transportation services due to financial losses is devastating news. I have recently written to Assembly Speaker Carl Heastie and the Assembly Chair of the Ways and Means Committee, Herman Farrell, Jr., along with our Democratic Assembly delegation from Onondaga County, regarding the urgent need for increased state transit operating aid and related capital projects to Upstate transit systems. Our total requested funding for this budget is \$25 million.

Upstate transit systems, including Syracuse-based CENTRO, continue to struggle financially. State funding to Upstate systems has been flat since 2009 while costs to provide services and transit ridership continue to grow. CENTRO officials have cut services and staff, raised fares, reduced employee benefits, and kept annual budget increases to an average of 2.2% over the last six years. At the same time, there has been no change in the amount of revenue received from the State.

Despite their efforts, they must continue to look at further cuts. These potentially include: eliminating bus service after 9 pm on weekdays, 7 pm on Saturdays, and all service on Sundays and holidays; eliminating more services for persons with disabilities; eliminating bus trips to Utica; and, eliminating other services in Oswego and Cayuga Counties.

If CENTRO is forced to take these steps, it will impact the lives of many citizens who rely on this service to get to work, to go to medical appointments to receive life-saving medical treatment such as dialysis, and due to age or disabilities, use this service to maintain an independent life-style. If these cuts were to happen, we will add another untenable challenge to our working poor.

I will do everything I can to include this vital funding in the NYS 2015-16 budget.

### Assemblyman Bill Magnarelli Appointed to Ethics Search Committee

On Friday, February 6, 2015, Assembly Speaker Carl Heastie appointed a bi-partisan search committee for an Executive Director of the new Assembly Office of Ethics and Compliance.

Following his commitment to ensure the highest ethical standards in the State Assembly, Speaker Carl Heastie said, "The door is wide open for real change in the State Assembly to make this institution more open, transparent and accountable to the citizens of this State. In order to accomplish this, I have appointed a diverse group of members from this body to conduct a comprehensive search to identify national experts in the area of ethics and governance. Residents of this great State rightly expect government that is honest and beyond reproach, and this new office will work to ensure that their elected representatives are living up to the highest ethical standards."

Speaker Heastie said the search committee will be comprised of the following six members who have extensive experience in the practice of law and ethics:

- *Assemblyman Todd D. Kaminsky* – spent a decade in public service as a federal prosecutor (Assistant United States Attorney for the Eastern District of New York) and assistant district attorney.
- *Assemblyman William B. Magnarelli* – a graduate of the Syracuse University College of Law, *Cum Laude*, and former Captain in the Army Reserves who has previously served as Chair of the Assembly Ethics Committee.
- *Assemblywoman Janet L. Duprey* – a dedicated public servant and currently serves as a member of the Assembly Ethics and Guidance Committee.
- *Assemblywoman Shelley Mayer* – a graduate of the Buffalo School of Law, served as an assistant attorney general in the office of the New York State Attorney General.
- *Assemblyman Philip Ramos* – served 20 years in the Suffolk County Police Department, retiring as a detective.
- *Assemblywoman Michele R. Titus* – served as an attorney for the New York City Board of Education, the Consumer Frauds Bureau of the New York State Attorney General's Office and the Integrity Bureau at the Queens County District Attorney's Office.

Assemblyman Magnarelli said upon his appointment, "The vast majority of the men and women with whom I have served in the Assembly are ethical stewards of the public trust, but the reality is that in a few cases that trust is misplaced. I am committed to working with Speaker Heastie and with my colleagues on both sides of the aisle to move the People's house out from under the dark shadows that envelop us and into the bright light that public service was always meant to be. I am proud to be a member of his search committee and grateful to the Speaker for putting his faith in us."

## Income Tax Time:

### Tax credits available to help you save money

Too often, hardworking families miss the opportunity to save hundreds or even thousands of dollars in federal and state tax credits. These tax credits are in place to help families make their hard-earned dollars stretch just a little farther.

To help make sure you and your family don’t miss out on these tax credits, here are programs you may qualify for:

- The Empire State Child Credit, a refundable tax credit worth up to \$330 per child for ages 4-16;
- The Child and Dependent Care Credit, a tax credit based on a sliding income scale for working parents who pay for child care or those who live with a spouse or dependent who is physically or mentally incapable of self-care;
- The Federal Child Tax Credit, a non-refundable tax credit of up to \$1,000 per child under the age of 17, or the refundable Additional Child Tax Credit; and
- The Real Property Tax Credit, a refundable tax credit worth up to \$375 for eligible homeowners and renters.

Additionally, if eligible, you may be able to recoup portions of the income taxes that were withheld from your paycheck throughout the year. In fact, through an often overlooked tax break called the Earned Income Tax Credit (EITC), eligible taxpayers can get extra cash back from the IRS or New York State. These savings help many families cover their monthly bills and allow them to put some money away for the future.

Tax season doesn’t need to be a stressful time of year, and assistance is available to help you prepare your taxes. The IRS-certified volunteers with the Volunteer Income Tax Assistance (VITA) program provide free tax preparation services to individuals with families with annual incomes of \$53,000 or less.

For those 60 years of age and older, the Tax Counseling for the Elderly (TCE) program can also provide assistance at no cost to you. I encourage you to set aside some time and check what tax credits you’re eligible for. These tax credits exist for our benefit; if you’re eligible, they can help you lower your taxes and even put money back in your pocket.
