Assemblymember Harry Bronson: Supporting Our Communities

This year, Assemblymember Bronson helped pass a reproductive rights legislative package to:

- **Protect the rights of women** who come to New York for reproductive care (Ch. 218 of 2022)
- **Prohibit law enforcement** from arresting anyone performing or seeking a legal abortion in New York (Ch. 219 of 2022)
- **Protect health care practitioners** from professional misconduct charges solely for performing, recommending or providing reproductive health services to patients from states where these services are illegal (Ch. 220 of 2022)
- **Keep medical malpractice insurers from taking adverse action** against a provider solely because they legally provided reproductive care services to someone from out of state or via telehealth to a person who is out of state (Ch. 221 of 2022)
- Help **protect the privacy of reproductive health care service providers** and their immediate family members, employees, volunteers and patients (Ch. 222 of 2022)

Additionally, Assemblymember Bronson passed legislation to support local workers and families, including bills to:

- Provide up to \$500 million per year in Excelsior Jobs Tax Credits for semiconductor manufacturing companies that build **new facilities in New York State and create good-paying jobs** (A.10507)
- Allow mental health counselors, marriage and family therapists and psychoanalysts to **diagnose patients and develop assessment-based treatment plans** (Ch. 230 of 2022)
- Require public agencies and authorities that purchase rock salt or sodium chloride to **purchase salt mined in the United States** in most cases (A.7919)
- **Provide a recourse to freelance workers** experiencing wage theft and other labor law violations (A.9368)
- Keep a more **accurate public record of populations** by sexual orientation and gender identity or expression (A.2632-A)
- Require a cost comparison between state agencies and outside consultants before entering a contract in order to **save taxpayer money** (A.8159)
- Help ensure permanently disabled workers with significant injuries can either return to work or access **adequate wage-replacement benefits** if they are unable to do so (A.1118)
