### On the state level...

All not-for-profit applicants must now pre-qualify on the NYS Grants Reform website at grantsreform.ny.gov/grantees in order to apply for certain New York State grant solicitations. Potential not-for-profit applicants are strongly encouraged to begin the process of registering and pre-qualifying immediately as this is a lengthy process.

### New York State Developmental Disabilities Planning Council (DDPC), Grant for "Quick Guides: Tools for Independence"

The DDPC is announcing availability of grant funds to fund one grantee up to \$300,000 (\$100,000 per year, for three years) to develop a Quick Guide series and provide statewide trainings on independence and daily living for people with intellectual and developmental disabilities (I/DD). All DDPC funds are intended to minimize gaps in services and to increase the independence, productivity, integration and inclusion of individuals with I/ DD and their families into the community. These funds may not be used for activities that duplicate or supplant what is already available or required under existing laws.

- Eligibility: Eligible applicants are any organizations that would be included in the following categories:
  - Nonprofit organizations (Note: the lead applicant cannot be a forprofit organization; however, for-profit organizations may serve as subcontractors to the lead applicant);
  - Public or private institutions, such as universities, colleges, hospitals;
  - Disability-service organizations;
  - Community-based organizations;
  - Tribal organizations; and
  - Consortia, groups or partnerships among organizations.
- **Funding:** \$300,000
- Deadline: June 7, 2019, 3 p.m. Note: Letter of intent required by May 17, 2019, 3 p.m.

### New York State Office of Temporary and Disability Assistance (OTDA), Solutions to End Homelessness Program (STEHP)

STEHP supports comprehensive programs that are designed to help maintain and improve the quality of emergency and transitional shelters and drop-in centers for homeless individuals and families. STEHP assists organizations to meet the costs of operating programs that provide comprehensive supportive services aimed at housing stabilization, rapid re-housing services (obtaining a permanent living situation) and eviction prevention assistance to individuals and families.

- Eligibility: Local government offices, local social services districts, tribal organizations and nonprofit corporations. All applicants must have certification from the local social services district.
- **Funding:** \$15 million
- **Deadline:** June 14, 2019, 3 p.m.

# On the federal level...

### U.S. Department of Housing and Urban Development (HUD), Office of Public and Indian Housing, Choice Neighborhoods Planning Grants Program

The Choice Neighborhood Planning Grants Program helps communities transform neighborhoods by redeveloping severely distressed public and/or HUDassisted housing and catalyzing critical improvements in the neighborhood, including vacant property, housing, businesses, services and schools. The program includes Planning Grants, two-year grants to assist communities with severely distressed public or HUD-assisted housing in developing a successful neighborhood transformation plan and building the support necessary for that plan to be successfully implemented. Planning and Action Grants are three-and-a-half year planning grants that pair planning with action.

### Eligibility:

- Eligible Target Housing: Requires that the applicant focus on severely distressed public housing and/or HUD-assisted housing (the terms "severely distressed," "public housing" and "assisted housing" are defined in the NOFA).
- Eligible Neighborhood: Must be in a distressed neighborhood (criteria in NOFA).
- Eligible Applicant: Only local governments, public housing agencies, tribal entities and nonprofits are eligible to apply. Individuals are not eligible.
- **Funding:** \$5 million
- **Deadline:** June 10, 2019

### NWEA, Educators for Equity Grant Program

NWEA, a not-for-profit provider of assessment solutions headquartered in Portland, Oregon, has announced the launch of its Educators for Equity Grant Program, a new initiative aimed at helping schools foster academic growth and achievement for pre-K-12 students who face systemic barriers to academic opportunities. Fundable activities can include curricula as well as programs that support student engagement in the classroom; help facilitate dialogue amongst educators, students and families about high academic expectations; and provide needed academic supports such as academically focused after-school programs.

- Eligibility: Must be a public school or not-for-profit organization in the U.S. serving students pre-K through 12th grade.
- **Funding:** At least three grants of up to \$10,000 will be awarded.
