Dear Speaker Heastie,

I am pleased to submit the 2021 Annual Report for the Assembly's Standing Committee on Governmental Employees.

The Committee advanced significant legislation throughout the 2021 Legislative session year.

Prominently, Chapter 78 of the Laws of 2021 extends the sunset date of the benefits created in Chapter 89 of the Laws of 2020 that permit the beneficiaries of any state employees and officers who contracted COVID-19 while at work and died due to such diagnosis to receive an accidental death benefit.

To protect our first responders, educators, and public health professionals, many of whom work on the frontlines, the Committee advanced Chapter 77 of the Laws of 2021. This law provides both private and public employees up to four hours of paid leave for each COVID-19 vaccine injection. The Committee also advanced Chapter 214 of the Laws of 2021, which prohibits public employers from taking disciplinary action against an employee for the use of any leave of absence to quarantine or treat a COVID-19 diagnosis or contact.

This is a small sampling of the legislation the Committee has reported this year, highlighting its commitment to the working men and women in our state. This annual report provides greater details on the Committee's accomplishments, and reports on the various legislative proposals considered by the Committee this year.

I would like to thank the Committee members and staff for all their hard work and dedication to our state's public employees. Additionally, I would like to thank the public employee organizations, unions and the many government officials who have helped make this year a successful one. I look forward to continuing to serve as the Committee chair.

I also thank you for your guidance and support, which was vital to the accomplishments of the Committee during the 2021 Legislative Session.

COMMITTEE SUMMARY

The New York State Assembly Standing Committee on Governmental Employees oversees legislation and policy proposals concerning the civil service law and the public pension and retirement systems.

Throughout the 2021 Legislative Session, the Committee strove to protect the rights of and provide basic workplace protections to all employees and officers in the State of New York. In order to complete our mission, we have worked earnestly to pass legislation that relates to the fair and equal compensation of public employees, disciplinary and hearing proceedings, civil service examinations and appointments, disability and retirement benefits for uniformed employees, the right to organize collective bargaining units, and the ratification of collective bargaining agreements. The Committee has also reviewed legislation altering pension and disability benefits and eligibility for such benefits for certain members of the public pension and retirement systems. At the same time, the Committee has reviewed policies to ensure that legislation does not undermine any of the pension funds on which public retirees depend. Through our work, the Committee seeks to enhance the governing structure of pension systems as well as maintain their sustainability.

Additionally, the Committee on Governmental Employees is responsible for the mandate of legislative initiatives protecting the individuals our communities rely on the most: our public safety personnel. Our police, fire, emergency medical technicians, sanitation and corrections workers risk their lives to protect our citizens and maintain the services New Yorkers rely on every day. In recognition of their dedicated service, the Committee has advanced legislation that aims to enhance the effectiveness and efficiency of the law enforcement, public safety and security organizations located within New York State.

During the 2021 Legislative Session, a total of 268 legislative proposals were referred to the Committee on Governmental Employees. The Committee reported 78 bills. Of those proposals, 62 passed both Houses. Of those, 55 were chaptered and 7 were vetoed.

I. COVID-19 BENEFITS

The COVID-19 pandemic has had a significant toll on New York State's public workforce, many of whom have been on the frontlines throughout the pandemic. Our educators, first responders, and public health professionals have shown commendable dedication. The following significant legislation was advanced by the Committee to protect the individuals engaging in in-person work throughout this challenging time.

A.3354-B (Fall) / S.2588-A (Gounardes) – Chapter 77

This law grants public and private employees a paid leave of absence of up to four hours for each COVID-19 vaccine injection. The law provides that employees shall be able to receive a greater number of hours pursuant to a collectively bargained agreement or as authorized by the employer and that an employee shall not be retaliated against by an employer for taking leave to receive the COVID-19 vaccine.

A.3988 (Abbate) / S.4681 (Gounardes) – Chapter 78

This law extends the COVID-19 accidental death benefit established in Chapter 89 of the Laws of 2020 for state and local employees to December 31, 2022. This law allows an accidental death benefit to be awarded to the statutory beneficiary of a public employee who reported for work to any location other than his or her home on or after March 1, 2020 and died of COVID-19 or a COVID-19 related illness within forty-five days after any such date.

A.4063-A (Abbate) / S.4201-A (Savino) – Chapter 214

This law prohibits public employers from dismissing or taking other disciplinary action against a public employee related to the use of any leave to quarantine, seek medical treatment, or engage in other activities related to a COVID-19 diagnosis or contact.

II. CIVIL SERVICE PROTECTIONS

The State of New York is home to some of the most dedicated servicemen and women in the country. As such, it is crucial that we offer them the same level of support and safety in return. In acknowledging the vital role of a robust public sector workforce, the Committee has worked diligently to introduce and advance the following legislative proposals.

A.6096 (Abbate) / S.6065 (Gounardes) – Chapter 137

This law extends certain statutory provisions of law that allow a public employee to petition before the Public Employment Relations Board or the New York City Board of Collective Bargaining and receive injunctive relief for an improper practice charge from June 30, 2021 to June 30, 2023.

A.7023 (Abbate) / S.6737 (Gounardes) – Chapter 120

This law extends statutory provisions that provide compulsory arbitration for the resolution of impasses during collective bargaining negotiations between the Metropolitan Transit Authority, the New York City Transit Authority, or the Triborough Bridge and Tunnel Authority and their recognized employee organizations from July 1, 2021 to July 1, 2023.

A.7465 (Cruz) / S.2057 (Sepulveda) – Chapter 401

This law directs the State Civil Service Department and local municipal commissions to promote each competitive examination issued by the department or commission. The law also directs the State Civil Service Department to offer exams at any location or locations that it deems suitable and to make efforts to use SUNY Educational Opportunity Centers when selecting testing sites.

A.7935 (Abbate) / S.7100 (Gounardes) – Chapter 386

This law extends the deadline by which New York City Department of Citywide Administrative Services (DCAS) employers must implement a plan to further reduce the number of excess provisional appointments to December 31, 2023. The law also extends the deadline by which DCAS employers must submit a progress report on the number of provisional appointments that have been reduced and the number of provisional appointments remaining to the Governor, Speaker of the Assembly, Temporary President of the Senate and the Mayor of New York City to December 31, 2022. The law authorizes an increase in the percentage goal for substantial compliance to six and one-half percent and provides that DCAS employers shall not administer more than one Qualified Incumbent Exam per title.

III. BENEFITS FOR UNIFORMED PERSONNEL

During this legislative session year, the Committee has advanced legislation seeking to provide and extend eligibility for disability benefits to certain uniformed members and provide financial stability to injured members and their families. The following are such noteworthy pieces of legislation.

A.3476 (Abbate) / S.2934 (Kamisky) – Chapter 245

This law adds the titles of police medics, police medic supervisors, and members who perform police medic-related services to Retirement and Social Security Law in order to reflect nomenclature changes made by the Nassau County Civil Service Commission. This law ensures that members whose title names changed shall continue to be eligible for retirement and disability benefits.

A.6384-A (Abbate) / S.4961-B (Gounardes) – Chapter 424

This law permits members of the New York State and Local Retirement System who participated in World Trade Center Rescue, Recovery, or Cleanup operations as non-members employed by a

public employer within the State and who subsequently purchased pension credits covering such period to be eligible for the World Trade Center presumption benefit.

A.6663 (Abbate) / S.6512 (Gounardes) – Chapter 370

This law limits the maximum loan amount that Tier VI members of the New York State Teachers' Retirement System who join the system on or after July 1, 2022 may borrow each year to be no greater than fifty percent of a member's total contributions, or \$50,000, whichever is less. This law also makes technical corrections to existing loan provisions in sections of Retirement and Social Security Law.

A.6934-A (Abbate) / S.7009 (Savino) – Chapter 425

This law allows a member of a public retirement system to electronically submit a World Trade Center notice of participation through a secure online portal maintained by the member's retirement system.

A.7124 (Joyner) / S.6483 (Gounardes) – Chapter 327

This law applies a three percent cost-of-living increase to the salary used in the computation of the special accidental death benefit paid to the beneficiary or beneficiaries of a deceased uniformed member of the New York City Employees' Retirement System or the New York State and Local Employees' Retirement System for deaths occurring before 2021.

A.7181 (Conrad) / S.6513 (Mannion) – Chapter 329

This law authorizes the New York State Teachers' Retirement System to accept alternate methods of postal mail services and offer expanded options to members for submitting and filing retirement system forms and applications.

A.7182 (Buttenschon) / S.6618 (Gounardes) – Chapter 376

This law provides that the post-retirement ordinary death benefit of members of the New York State Teachers' Retirement System who joined the retirement system at an age greater than sixty and died during their third year of retirement shall not be reduced below ten per centum of the benefit in force at the time of retirement.

A.7204 (Abbate) / S.5728-A (Gounardes) – Chapter 357

This law provides that for deaths occurring on or after July 1, 2021, the beneficiaries of deceased members of the New York City Teachers' Retirement System will no longer be permitted to establish tax-deferred accounts through the tax-deferred annuity (TDA) program. This program allows beneficiaries to distribute death benefit payments over a period of years, as opposed to receiving the benefit as a lump sum. This has frequently led to negative consequences related to taxation. Inherited IRAs, which allow beneficiaries to spread out death benefit payments over time

without negative tax effects, are widely available, therefore the TDA program is no longer necessary.

A.7958 (Abbate) / S.7159 (Gounardes) – Chapter 391

This law extends for two fiscal years the current seven percent per annum statutory rate of interest used by the Chief Actuary for the New York City Employees' Retirement System, Teachers' Retirement System, Board of Education Retirement System, Police Pension Fund and Fire Department Pension Fund in valuing retirement system liabilities for the purpose of computing the amount of employer contributions to those systems. The law also extends for two fiscal years the current rates of special interest, additional interest and supplementary interest, which govern the amount of interest to be paid into certain constituent funds of the City retirement systems, and the amount of interest to be credited on accumulated member contributions and reserves-for-increased-take-home-pay of Tier I and Tier II members of those retirement systems.

IV. PENSION & CIVIL SERVICE LEGISLATION FOR INDIVIDUALS

The following legislation pertains to certain New York State Civil Service employees and members of New York State Retirement Systems concerning eligibility for certain retirement plans and tiers, competitive civil service examinations, and fields of employment.

A.4675 (Tague) / S.4404 (Jordan) – Chapter 811

This law authorizes the County of Columbia to offer Theodore Blank, a member of the optional twenty-five-year retirement plan for sheriffs, undersheriffs, deputy sheriffs, and corrections officers of the New York State and Local Employees' Retirement System employed as a Columbia County deputy sheriff, service credit in an employer-elected twenty-year retirement plan.

A.5325 (Lupardo) / S.4117 (Akshar) – Chapter 530

This law authorizes the Village of Endicott to offer Jennifer Quinn, a member of the New York State and Local Police and Fire Retirement System employed as a police officer with such village, full service credit in a twenty-year retirement plan.

A.5577 (Byrnes) / S.3594 (Gallivan) – Chapter 703

This law allows Shawn Coveny, a Tier VI member of the New York State and Local Employees' Retirement System employed at the New York State Department of Corrections and Community Supervision, to elect into Tier IV of such retirement system by changing his date of membership to May 31, 2008, upon filing a request with the State Comptroller.

A.6383 (Burke) / S.4401 (Gallivan) – Chapter 532

This law grants Jason M. Schiedel, a member of the New York State and Local Police and Fire Retirement System employed as captain of patrol by the Town of Orchard Park Police Department,

retroactive service credit for the period employed as a part-time police officer with the Village of Gowanda from February 1995 to February 2003 in his current pension plan upon filing a request with the State Comptroller.

A.6670 (Gunther) / S.5691 (Griffo) – Chapter 538

This law allows David Goodman, a Tier VI member of the New York State and Local Employees' Retirement System, to elect into Tier IV of such retirement system by changing his date of membership to November 24, 2009, upon filing a request with the State Comptroller.

A.6725 (Cahill) / S.4343 (Hinchey) – Chapter 531

This law authorizes Ulster County to offer participation in an optional twenty-year retirement plan to Kyle Frano, Joseph Sciutto, and Emmett Vedder III, employed as deputy sheriffs in such county, who may elect to participate in such plan upon filing a request with the State Comptroller.

A.6735 (Tague) / S.4779 (Hinchey) – Chapter 537

This law authorizes the Village of Athens to offer participation in an optional twenty-year retirement plan to Edward Tercasio, Jr., employed as a police officer with such village, who may elect to participate in such plan upon filing a request with the State Comptroller.

A.7444 (Abbate) / S.7169 (Reichlin-Melnick) – Chapter 544

This law authorizes the Town of Orangetown to offer participation in a special twenty-year retirement plan to Patrick J. Casey, Elizabeth M. Muckell, and Keith E. Trojan, employed as police officers with such town, who may elect to participate in such plan upon filing a request with the State Comptroller.

A.7793 (DeStefano) / S.6822 (Palumbo) – Chapter 817

This law allows Kevin Moriarty, a Tier VI member of the New York State Teachers' Retirement System employed by the University of Stony Brook, to elect into Tier IV of such retirement system by changing his date of membership to July 1, 1998, upon filing a request with the head of the retirement system.

A.7880-A (Miller B.) / S.7154 (Skoufis) – Chapter 388

This law authorizes Gina Kehoe, a part-time police officer in the Town of Montgomery, to take the competitive civil service examination for appointment as a full-time police officer in the Town of Montgomery Police Department.

A.7964 (Simpson) / S.5544 (Stec) – Chapter 708

This law allows Jaime Laczko, a member of the New York State and Local Employees' Retirement System employed as a forest ranger with the New York State Department of Environmental

Conservation, to elect to participate in an optional twenty-five-year retirement plan upon filing a request with the State Comptroller.

A.8012 (Meeks) / S.7187 (Cooney) – Chapter 685

This law authorizes payment of the remaining annual compensation of late Member of the Assembly David F. Gantt, who died on July 1, 2020, to his surviving children.
